Dear Judge Ponsor,

Dr Scott Lively's Alleged "Crimes against Humanity"

Please forgive me for troubling you with this letter, but I am deeply concerned about the pressures that must have been put upon you. I am dismayed to hear that you have completely reversed your January ruling in favour of Dr Scott Lively. You will remember that you were: "struggling to see actionable behaviour" in anything Lively did or said, and added that you "couldn't see that any of Lively's conduct amounts to "persecution" or "conspiracy." I can only surmise that your recent completely contrary ruling denying all of the points previously raised by Dr Lively's lawyers and accepted by you, has resulted from extreme pressure and deceitful arguments forced upon you by the Soros-backed CCR activists.

I am sure you are aware that this case presents a tremendous issue of truth and justice. A judgment against Scott Lively, who has an unblemished and enviable record of public service and integrity, would not only be a most flagrant injustice, but would also mark a fatal milestone in both the suppression of free speech and the remorseless advance of the anarchic homosexual agenda.

As one who has studied the strategies of the homosexual activists and written articles and briefing papers to our political leaders, I am very aware of the dishonesty of the 'pink lobby' and of the ruthless intimidation they apply to suppress all dissenting voices. This entirely explains their action against Scott Lively and doubtless the pressures they have brought to bear on you.

It would be a complete travesty to prosecute a man who has devoted his life to upholding God's laws for the good of the family and society, and even more so to do that on the basis of two flagrant but largely unchallenged lies. These key deceptions of the 'pink lobby' are firstly that their same-sex attraction is innate, immutable/genetic, and secondly that their practices are basically good, 'normal' and fully comparable to their heterosexual equivalents.

Scott Lively's great "crime" in their eyes is threefold; viz: to have exposed the fraudulence of the first deception, the anarchic and ruthless homosexual agenda, and the true dysfunctionality and harmful nature of homosexual practices. The crucial question one needs to ask the activists is simply "On what scientific evidence do you base your claim that homosexual 'orientation' is innate and immutable rather than merely a lifestyle choice and really a culpable yielding to temptation, essentially no different from drug addiction or even adultery? The answers you will get will be either outraged assertions that "It is universally accepted that such orientations are immutable" or else they will cite some pseudo-scientific study, which will undoubtedly have been comprehensively exposed as deliberately fraudulent in Ryan Sorba's definitive book "Born-gay" Hoax Debunked" (freely downloadable) (and in Scott's writings too). Further unjustifiable outrage will undoubtedly result, if as one should, you then ask a second question about the scientifically proven facts of the extremely detrimental social and medical effects of homosexual practices. The activists have been very successful in sanitising the realities of their high-risk lifestyle by suppressing these unpalatable facts, but, for the good of society, it is absolutely vital that the truth be proclaimed. The government rightly insists on health warnings on cigarette packets, but the life-threatening consequences of homosexuality are markedly worse and the truth is that we should very much more warn our young people about them rather than promote them in our sex education curriculum as is clearly planned. Equally we should help to protect other countries from the awful damage that will undoubtedly ensue if homosexuality is given legal encouragement and promotion.

I am sure you know in your heart that, when it comes to a decision as to whether it is Scott Lively or the homosexual activists, who are truly seeking the good of society at large (both in USA and Uganda), you can have no doubt what the decision should be. Assuredly you will be vilified by the activists if you rule in favour of Scott, but you will have the satisfaction of knowing that you enjoy the support of the great majority of your people and have done the right thing in the eyes of God and justice.

I would like to conclude by quoting from the MassResistance website, where godly honest people have accurately summed up the huge and worldwide significance of this case as follows:

"However, their bigger goal is worldwide. At the end of their complaint against Lively the plaintiffs declare what they are asking for. Included is: "a declaratory judgment holding that Defendant's conduct was in violation of the law of nations." And a preponderance of the arguments in the complaint clearly lead in that direction. Thus, it's clear that their real goal is much bigger than just punishing Scott Lively.


