WHEREAS, the parties agree that Defendants will, therefore, have until February 15, 2017, to answer or otherwise respond to Plaintiffs' First Amended Complaint (ECF 13) and to respond to Plaintiffs' Motion for Preliminary Injunction (ECF 14);

WHEREAS, by entering into this stipulation, Plaintiffs and Defendants further agree that Defendants preserve, and nothing in this stipulation shall be deemed to waive, any and all defenses that may be asserted in this matter.
