APPELLANT’S DOCKETING STATEMENT

In accordance with Circuit Rules 3(c) and 28(a), Plaintiff-Appellant Marsha Wetzel hereby submits this docketing statement.

1. **Statement of Jurisdiction for the United States District Court:** Plaintiff brought this action pursuant to 42 U.S.C. § 3613, alleging sex discrimination and retaliation by Defendants in violation of the Fair Housing Act, 42 U.S.C. §§ 3604 and 3617. Accordingly, the District Court had general federal question jurisdiction under 28 U.S.C. §§ 1331 and 1343. Further, pursuant to 28 U.S.C. § 1367(a), the District Court had supplemental jurisdiction over Plaintiff’s discrimination and retaliation claims under the Illinois Human Rights Act, 775 Ill. Comp. Stat. Ann. 5/1-103, 5/3-102, and 5/3-105.1, because those claims are so related to the Plaintiff’s federal claims that they form part of the same case or controversy.

2. **Statement of Jurisdiction for the United States Court of Appeals:** The United States Court of Appeals for the Seventh Circuit has appellate jurisdiction pursuant to 28 U.S.C. § 1291. Appellant seeks review from the Judgment and the Order and Opinion of the United States

District Court for the Northern District of Illinois dismissing Plaintiff's claims of housing discrimination, entered January 18, 2017. Appellant filed her Notice of Appeal on February 17, 2017. Because appeal is taken from a final judgement, adjudicating all of the claims with respect to all of the parties, no information pursuant to Circuit Rule 28(a)(3) is necessary to determine whether the order is immediately appealable.

3. **Prior or Related Appellate Proceedings:** There have been no prior or related appellate proceedings in this case.

4. **Prior Trial Proceedings:** There has been no prior litigation in the district court.

5. **Parties Appearing in an Official Capacity:** No party to the litigation appears in an official capacity.
