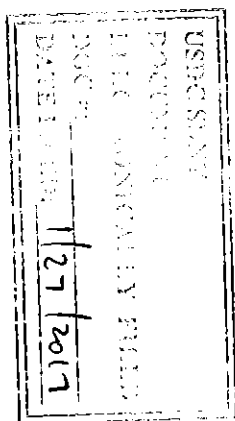
**CIVIL CASE DISCOVERY

ORDER**

This Civil Case Discovery Plan and Scheduling Order is adopted, after consultation with counsel, pursuant to Rules 16 and 26(f), Fed. R. Civ. P.


1. The parties do not consent to conducting all further proceedings before a Magistrate Judge, including motions and trial, pursuant to 28 U.S.C. §636(c).
2. This case is to be tried to a jury.
3. There are no material additional parties that require joinder in the instant action.
4. Amended pleadings may be filed until March 3, 2017.
5. Interrogatories shall be served no later than April 29, 2017 and responses thereto shall be served within thirty (30) days thereafter. The provisions of Local Civil Rule 33.3 shall not apply to this case.
6. Request for production of documents, if any, shall be served no later than April 19, 2017.
7. Non-expert depositions shall be completed by December 1, 2017.
 - a. Unless counsels agree otherwise or the Court so orders, depositions shall not be held until all parties have responded to any first requests for production of documents.
 - b. Depositions shall proceed concurrently.



- c. Whenever possible, unless counsel agree otherwise or the Court so orders, non-party depositions shall follow party depositions.
8. Any further interrogatories, including expert interrogatories, shall be served no later than October 2, 2017.
9. Requests to Admit, if any shall be served no later than ~~November 3, 2017~~ ^{November 3,} 2017.
10. Expert reports shall be served no later than December 1, 2017.
11. Rebuttal expert reports shall be served no later than January 19, 2018.
12. Expert depositions shall be completed by March 9, 2018.
13. Not Applicable.
14. ALL NON-EXPERT DISCOVERY SHALL BE COMPLETED BY December 8, 2017.
15. Any motions shall be filed in accordance with the Court's Individual Practices.
16. This Civil Case Discovery Plan and Scheduling Order may not be changed without leave of Court (or the assigned Magistrate Judge acting under a specific order of reference).
17. The Magistrate Judge assigned to this case is the Hon. Paul E. Davison.
18. If, after entry of this Order, the parties consent to trial before a Magistrate Judge, the Magistrate Judge will schedule a date certain for trial and will, if necessary, amend this Order consistent therewith.
19. The next case management conference is scheduled for March 23, 2018, at 10:00 am.
