**READ THIS ORDER CAREFULLY.
IT CONTROLS THE SETTLEMENT PROCEDURE FOR THIS CASE.**

1. **Presence of Lead Counsel.** The attorney attending the settlement conference must be the lead trial counsel.
2. **Presence of All Parties.** All parties to the litigation must attend the settlement conference. A representative with *unrestricted* settlement authority must appear on behalf of corporations and other business entities. In the case of lawsuits


1 involving the United States or any of its agencies, the Assistant
2 United States Attorney in charge of the case must appear with the
3 full measure of settlement authority provided by his or her
4 superiors within the United States Attorney's Office.

5 3. **Insurance Matters.** In cases involving insurance, a
6 representative with *unrestricted* settlement authority must appear
7 on behalf of the insurance company.

8 4. **Confidential Settlement Letters.** A party may, at its
9 option, submit a confidential settlement letter no later than the
10 day before the settlement conference. The letter should not be
11 filed, but should be submitted directly to Chambers of Judge Dean
12 D. Pregerson, Room 244-J, U.S. Courthouse, 312 North Spring Street,
13 Los Angeles, California 90012 or email them the the Courtroom
14 Deputy Clerk at john_chambers@cacd.uscourts.gov. The letter should
15 set forth the party's statement of the case and the party's
16 settlement position, including the last offer or demand made by the
17 party and a statement of the offer or demand the party is prepared
18 to make at the settlement conference. The settlement conference
19 letter shall be returned to the party that submitted the letter at
20 the end of the settlement conference.
