**UNOPPOSED MOTION TO EXTEND DEADLINE TO FILE REPLY BRIEF IN
SUPPORT OF MOTION TO DISMISS**

Pursuant to Local Rule 7.1, Plaintiff United States of America (“United States”) respectfully requests that the Court extend its deadline to file a reply brief in support of the United States’ and Defendants’ joint motion to dismiss (ECF No. 164) from October 5, 2017, to October 12, 2017. This is the first time that this deadline would be extended and the extension of this deadline would not require the extension of any other deadlines in this case.¹ The United States requests this extension because it requires additional time to consider and respond to the legal arguments raised in Plaintiff-Intervenor’s response to the joint motion to dismiss.
