**DEFENDANTS' CONSENT MOTION FOR AN EXTENSION OF TIME
TO RESPOND TO PLAINTIFFS' FIRST AMENDED COMPLAINT**

Defendants hereby file this consent motion for an extension of ten (10) days, until December 15, 2017, to respond to Plaintiffs' First Amended Complaint, ECF No. 39. In support thereof, Defendants state as follows:

1. Plaintiffs filed their First Amended Complaint on September 14, 2017. ECF No. 39.
2. Defendants responded on October 12, 2017, with a motion to dismiss and opposition to Plaintiffs' motion for a preliminary injunction. ECF No. 52.
3. On November 21, 2017, the Court ruled on Defendants' motion to dismiss, granting it in part and denying it in part. ECF No. 85 at 53. The Court dismissed Count III and allowed Counts I and II to proceed. *Id.*
4. Under Federal Rule of Civil Procedure 12 (a)(4)(A), Defendants have fourteen (14) days from the entry of the Court's denial of portions of their motion to dismiss, or until December 5, 2017, to file a responsive pleading.

5. Because of recent deadlines in other cases, Defendants need an additional ten (10) days, until December 15, 2017, to respond to Plaintiff's First Amended Complaint.

6. Defense counsel has conferred with Plaintiff's counsel regarding this motion, and Plaintiffs consent to the requested extension.

WHEREFORE, Defendants respectfully request that the Court enter an order extending the time for Defendants to respond to Plaintiffs' First Amended Complaint until December 15, 2017.
