**CONSENT MOTION TO EXTEND THE DEADLINE TO RESPOND TO
MOTION TO DISMISS PLAINTIFF'S AMENDED COMPLAINT**

Plaintiff Jameka K. Evans (“Plaintiff”) submits to the Court this Consent Motion to Extend the Deadline to Respond to Motion to Dismiss Plaintiff’s Amended Complaint (Dkt. 41). In support of her Motion, Plaintiff provides the following background.

On September 11, 2017, Plaintiff filed her Amended Complaint against Georgia Regional Hospital at Savannah (“GRHS”), Lisa Clark, in her official capacity (“Clark”), and Charles Moss, in his individual capacity (“Moss”) (collectively “Defendants”). (Dkt. 28).

On December 14, 2017, the Court issued an Order granting the consent motion filed by Defendant GRHS to extend the deadline to respond to Plaintiff's Amended Complaint (Dkt. 40).

On January 29, 2018, Defendants filed their Motion to Dismiss Plaintiff's Amended Complaint in Lieu of Answer. (Dkt. 41).

Plaintiff's response to Defendants' Motion to Dismiss is currently due on February 12, 2018. *See* L.R. 7.5.

Based on the availability of Plaintiff's counsel during the month of February, Plaintiff respectfully requests – and Defendants, through their counsel, consent to – a one-month extension to March 12, 2018 for Plaintiff to file a response to Defendants' Motion to Dismiss.

Plaintiff has conferred with Defendants' counsel and has authorization to represent to the Court that Defendants consent to the filing of this Motion.
