**STIPULATION OF PARTIAL DISMISSAL**

NOW COME the Parties through their respective counsel and stipulate to the dismissal of some of Plaintiffs' claims. The Parties stipulate to the dismissal of the following Counts from Plaintiffs' Complaint (ECF No. 1): Count 7 (FLSA claim for Ms. Schawe-Lane); Count 10 (Kentucky Wage and Hours Act claim for Ms. Schawe-Lane); Count 11 (Premises Liability claim for Ms. Schawe-Lane); and Count 20 (Premises Liability claim for Mr. Lane). The claims in Counts 7, 10, 11, and 20 are dismissed with prejudice and without costs to either Party. This stipulation does not dismiss, and the Parties do not intend to dismiss, the claims asserted in Counts 1, 2, 3, 4, 5, 6, 8, 9, 12, 13, 14, 15, 16, 17, 18, 19, and 21 of Plaintiffs' Complaint.
