WHEREAS Defendants have stated that they intend to move to
dismiss the complaint;

WHEREAS, pursuant to Federal Rule of Civil Procedure 4(d)(3), Defendants' responsive pleading is due on November 27, 2017;

WHEREAS, Plaintiffs' opposition, if a motion to dismiss is filed, would be due on December 18, 2017;

WHEREAS, Defendants' reply would be due on January 1, 2018; and

WHEREAS, the parties have conferred and agree, subject to the Court's approval, to the following schedule concerning the parties' responsive pleadings;

NOW, THEREFORE, IT IS HEREBY STIPULATED AND AGREED, by and between the attorneys for the undersigned parties, subject to the approval of the Court, as follows:

1. Defendants shall answer, move or otherwise respond to the Complaint by no later than December 15, 2017; any opposition papers shall be due no later than February 6, 2018; and any reply papers shall be due no later than February 20, 2018.
2. The Parties may seek the Court's permission to adjust the dates set forth in this Stipulation for other good cause.
