**PLAINTIFF’S MOTION FOR EXTENSION OF TIME TO RESPOND TO MOTIONS  
FOR ATTORNEY FEES FILED BY LAW OFFICE OF JILLIAN T. WEISS AND  
TRANSGENDER LEGAL DEFENSE AND EDUCATION FUND**

On July 5, 2018, this Court granted Defendants’ an extension of ninety (90) days to respond to Motions for Attorney Fees filed by Plaintiff, Law Office of Jillian T. Weiss, and Transgender Legal Defense and Education Fund until October 3, 2018. Plaintiff intends to respond to the Motions for Attorney Fees filed by Law Office of Jillian T. Weiss and Transgender Legal Defense and Education Fund as well. Plaintiff respectfully requests the same deadline to respond by October 3, 2018 pursuant to LCvR 7.1(h).

Plaintiff should be allowed to respond to the motions filed by her previous counsel separately from Plaintiff’s own motion. Jillian T. Weiss has indicated she does object to the requested extension. Counsel for TLDEF and for Defendants have not indicated their position at this time. Plaintiff has not requested an extension of any post-trial deadlines. All parties requested and received various extensions of previous, pre-trial deadlines.

There will be no impact on any scheduled deadlines if the extension is granted. Since Defendants' have already been granted the same extension, this will provide judicial efficiency, allowing the Court to review all responses at the same time.

For the reasons set forth above, Plaintiff respectfully requests an extension to respond to the Motions for Attorney Fees filed by Law Office of Jillian T. Weiss and Transgender Legal Defense and Education Fund by October 3, 2018, the same deadline as Defendants.
