**JOINT MOTION TO MODIFY BRIEFING SCHEDULE**

---

Pursuant to Fed. R. Civ. P. 16(b) and paragraph 3 of the Preliminary Pretrial Conference Order in this case, Defendants, State of Wisconsin Department of Employee Trust Funds, State of Wisconsin Group Insurance Board, and Richard Conlin (the “State Defendants”) and Plaintiffs, Alina Boyden and Shannon Andrews, respectfully request that this Court modify the schedule set at docket entry 80 for the opposition and reply briefs regarding State Defendants’ motion for summary judgment filed on June 1, 2018. Plaintiffs’ brief in opposition is currently due June 22, 2018, and State Defendants’ brief in reply is currently due July 2, 2018. In support thereof, both parties state as follows:

1. Although State Defendants filed their summary judgment motion on June 1, 2018, which automatically triggered the opposition and reply deadlines set forth above, they did not also file the required proposed findings of fact on June 1.

2. State Defendants' proposed findings of fact in support of their summary judgment motion were filed on June 5, 2018, at docket entry 88.

3. Because those proposed findings of fact were not also filed with the summary judgment motion on June 1, 2018, the parties agree that Plaintiffs' opposition deadline should be extended to June 25, 2018. The parties also agree that State Defendants' reply deadline should be recalculated based on that new date and rescheduled to July 5, 2018.

4. This adjusted briefing schedule will not prejudice either party or affect any other scheduling matters in this case. The parties are permitted to file dispositive motions until June 8, 2018, and these new proposed deadlines fall within the default briefing dates contemplated by that June 8 deadline.

WHEREFORE, both parties request that the Court amend the schedule set in docket entry 80 to: (1) extend Plaintiffs' deadline to file a brief opposing State Defendants' summary judgment motion to June 25, 2018; and (2) extend State Defendants' deadline to file a reply brief in support of their summary judgment motion to July 5, 2018.
