Plaintiffs and Plaintiff-Intervenor write to inform the Court of a new appeal docketed after they filed their Statement of Related Cases with their answering briefs on June 26, 2018 as required by 9th Circuit Rule 28-2.6.

On November 16, 2018, Defendants filed a notice of appeal from a September 18, 2018 order denying their motion to dissolve the preliminary injunction in *Stockman v. Trump*, No. EDCV 17-1799 JGB (KKx) (C.D. Cal. Sept. 18, 2018), *appeal docketed*, 18-56539 (9th Cir.). Plaintiffs previously filed a notice of supplemental authority regarding the *Stockman* decision in this appeal. Dkt. 111-1. The now-docketed *Stockman* appeal concerns a preliminary injunction enjoining the same policy challenged in this appeal. The opening brief in the *Stockman* appeal is currently due December 14, 2018. No. 18-56539, Dkt. 8.
