**DEFENDANT METROPOLITAN LIFE INSURANCE COMPANY’S  
SECOND CONSENT MOTION TO EXTEND ITS DEADLINE TO  
RESPOND TO PLAINTIFF’S COMPLAINT**

Now comes Defendant METROPOLITAN LIFE INSURANCE COMPANY (“MetLife”), pursuant to Federal Rule of Civil Procedure 6 and LR 6.1, and with Plaintiff SKYLER MUSGROVE’S (“Plaintiff”) consent, files this second consent motion for an extension of time to answer or otherwise respond to Plaintiff’s Complaint.

1. This action was filed on June 28, 2019. *See* Doc. No. 1.
2. On July 26, 2018 MetLife filed a Stipulation extending the time to respond to the Plaintiff’s Complaint until August 22, 2018. *See* Doc. No. 12.
3. On August 22, 2018, MetLife filed its first Consent Motion to Extend Its Deadline to Respond to Plaintiff’s Complaint (*See* Doc. No. 22), which the Court granted, extending MetLife’s time to respond to the Plaintiff’s Complaint until September 5, 2018. (*See* Doc. No. 23).

4. MetLife and Plaintiff have reached an agreement in principal regarding resolution of Plaintiff's claims against MetLife.

5. MetLife is asking for extension of time to respond to Plaintiff's Complaint until September 26, 2018 while the parties finalize the agreement.

6. Thus, MetLife requests, and Plaintiff consents to, an extension of MetLife's deadline to answer or otherwise respond to Plaintiff's Complaint up through and including September 26, 2018.

7. A proposed Consent Order effectuating this requested extension is attached hereto for the Court's convenience.
