**UNOPPOSED MOTION TO FILE SEALED DOCUMENTS**

On February 22, this Court held that Defendants Southeastern Oklahoma State University and the Regional University System of Oklahoma can file a supplemental appendix with their reply brief, the fourth brief on cross-appeal. Defendants and Plaintiff conferred on the substance of this appendix, and Plaintiff has requested that two documents in particular be filed under seal. Both were sealed exhibits to Plaintiff's summary judgment response below. *See* 10th Cir. Rule 10.4(D)(2).

The first document is a photocopy of the identification page of Plaintiff's passport; the second is a small portion of the deposition of sitting Oklahoma County Judge Richard Ogden. The documents are short, and have already been stripped down to their basic elements; *i.e.* these are essentially the redacted portions of broader documents. The passport should be sealed because it contains personal identification

information; the deposition should be sealed because it was based in part on sensitive and confidential information and involved a sitting jurist. (As a result, Defendants designated it as confidential below, pursuant to the district court's Consent Confidential Order. *See* District Court Docket No. 41.) For these reasons, Defendants respectfully move for permission to file the two attached documents under seal. Plaintiff does not object to the filing of this motion.
