8 Plaintiffs Aiden Stockman, Nicolas Talbott, Tamasyn Reeves, Jaquice Tate,

9 John Does 1-2, Jane Doe, Equality California, and Plaintiff-Intervenor the State of

10 California (collectively, “Plaintiffs”) and Defendants Donald J. Trump, Patrick M.

11 Shanahan, Joseph F. Dunford, Jr., Richard V. Spencer, Mark T. Esper, Heather A.

12 Wilson, and Kirstjen M. Nielsen (collectively, “Defendants,” and, along with

13 Plaintiffs, the “Parties”) by and through their respective counsel, hereby stipulate as

14 follows:

15 WHEREAS, Plaintiffs filed the above-captioned action on September 5, 2017

16 (ECF No. 1);

17 WHEREAS, on July 30, 2018, the Court entered the Civil Trial Scheduling

18 Order (ECF No. 116), establishing the current case schedule;

19 WHEREAS, the Parties have spent the last several months litigating appeals

20 and motions, related to this Court’s Order Denying Defendants’ Motion to Dissolve

21 the Preliminary Injunction (ECF No. 124), in the United States Court of Appeal for

22 the Ninth Circuit, *see Stockman v. Trump*, Dkt. No. 18-56539, and in the United

23 States Supreme Court, *see Trump v. Stockman*, Dkt. No. 18-678;

24 WHEREAS, on January 22, 2019, the United States Supreme Court (i) issued

25 an order staying this Court’s preliminary injunction pending disposition of

26 Defendants’ appeal in the United States Court of Appeal for the Ninth Circuit and

27 disposition of Defendants’ petition for writ of certiorari, if such writ is sought, and

1 (ii) denied Defendants’ petition for a writ of certiorari before judgment, *see Trump*
 2 *v. Stockman*, 586 U.S. ____ (2019);

3 WHEREAS, the Parties now agree that good cause exists to modify the case
 4 schedule; and

5 WHEREAS, the Parties have conferred and agree that the current case
 6 schedule should be modified to conform to the below modified schedule.
