**GLOUCESTER COUNTY SCHOOL BOARD'S UNOPPOSED MOTION FOR
EXTENSION OF TIME TO SERVE EXPERT DISCLOSURES**

Defendant Gloucester County School Board (“School Board”), by counsel, states as follows for its Motion for Extension of Time to Serve Expert Disclosures:

1. On September 26, 2018, this Court entered May 22, 2018, this Court entered a Rule 16(b) Scheduling Order setting this matter for trial on July 23, 2019 and setting various discovery deadlines. ECF Doc. 165.

2. Under the Scheduling Order, Plaintiff served a Rule 26(a)(2)(B) expert disclosure and report of Dr. Melinda Penn, M.D. on January 28, 2019. Under the Scheduling Order, expert disclosures to respond to, contradict or rebut Plaintiff’s expert disclosure are to be made on February 19, 2019.

3. The School Board seeks an extension of seven (7) days from February 19, 2019 to submit its expert disclosures.

4. There is no bad faith in the School Board’s request for an extension of time. All remaining deadlines under the Rule 16(b) Scheduling Order will remain in place.

5. Counsel for the School Board has conferred with Plaintiff's counsel who has represented that he will not oppose this Motion.

6. The School Board has dispensed with filing a brief in support of this motion pursuant to Local Rule 7(F)(2)(b).

WHEREFORE, for the foregoing reasons, Defendant Gloucester County School Board, by counsel, respectfully requests that this Court grant this Motion and extend the time for the School Board to serve its expert disclosures by seven days.
