AFFIDAVIT OF HARRISON HOLLIS

BEFORE ME, the undersigned authority, personally appeared Harrison Hollis, who being first duly sworn, on oath, deposes and says:

1. My name is Harrison Hollis. I am over the age of 18 and have personal knowledge of the facts testified to herein.
2. I have worked for the Channel 20 Division of Public Affairs of Palm Beach County ("Channel 20") since October 1999.
3. My title is Production Specialist II and my duties and responsibilities include recording, copying and storing BCC meetings on DVDs.
4. I have personal knowledge of the manner in which Channel 20 maintains and produces the video recordings of public meetings of the Palm Beach County Board of County Commissioners ("BCC"). I am a records custodian for Channel 20.

5. Channel 20 regularly films, broadcasts, and video-records the public meetings of the BCC to keep a public record of these meetings in accordance with the Florida Sunshine Law. The public can request a DVD copy of a filmed public meeting.

6. Channel 20 filmed the public meetings of the BCC on December 5, 2017 and December 19, 2017. The video recording of each of these meetings was kept and stored by Channel 20 in the regular, ordinary course of operations. The video recording of each meeting has been copied onto a separate DVD in accordance with the regular practices and procedures used by Channel 20 in responding to public records requests.

7. Attached as Exhibit 1 is DVD 1. DVD 1 is a true, complete, and accurate copy of the video recording of the December 5, 2017 public meeting of the BCC. DVD 1 is identical to the DVD that would have been produced in response to a public records request for the recording of the December 5, 2017 BCC meeting.

8. Attached as Exhibit 2 is DVD 2. DVD 2 is a true, complete, and accurate copy of the video recording of the portion of the December 19, 2017, public meeting of the BCC when the BCC considered the Ordinance at issue in this case. DVD 2 is identical to the DVD that would have been produced in response to a public records request for the recording of the December 19, 2017 BCC meeting.
