**PLAINTIFFS' UNOPPOSED MOTION FOR ONE-DAY EXTENSION OF TIME TO  
FILE MOTION FOR SUMMARY JUDGMENT**

Plaintiffs Cody Flack, *et al.*, respectfully move the Court for a one-day extension of time to file a motion for summary judgment in this case, from the current dispositive motion deadline of April 22, 2019, to April 23, 2019. The Court previously granted Plaintiffs a seven-day extension of the dispositive motion deadline from April 15, 2019 to April 22, 2019.

In support of this motion, Plaintiffs state that the current deadline, Monday, April 22, 2019, is the first business day after the Easter and Passover holidays, and that the unavailability of several attorneys and paralegals from Friday, April 19 through Sunday, April 21 because of religious holiday observances will make finalizing Plaintiffs' anticipated summary judgment motion, brief, and accompanying exhibits difficult. In addition, the supervising Relman, Dane & Colfax partner on the case, Jennifer Klar, will be unavailable on the current deadline, April 22, due to a surgical procedure, and will be unable to supervise the filing of Plaintiffs' motion on that day. The requested one-day extension will provide sufficient time to finalize and file the motion and supporting documents.

If granted, Defendants' response brief would be due on May 14, 2019 (extended from the current deadline of May 13, 2019), and Plaintiffs' reply brief, if any, would be due on May 24, 2019 (extended from the current deadline of May 23, 2019).

Defendants, through counsel, have advised Plaintiffs' counsel that they do not oppose this motion.
