**CERTIFICATION OF  
ARTHUR GOLDBERG**

I, Arthur Goldberg, certify as follows:

1. I understood the Permanent Injunction to prohibit Conversion Therapy (as defined in the Injunction) but only in the State of New Jersey. That is, I believed that the provision of such therapy outside New Jersey was not prohibited, and referrals to such therapy outside New Jersey were similarly not prohibited. I believed (and believe) that my actions complied with the Permanent Injunction.

2. The referrals did not involve either New Jersey clients or New Jersey therapists. In particular, I did not refer New Jersey clients to out-of-state therapists (or vice versa), nor refer New Jersey therapists to out-of-state clients (or vice versa).

3. Plaintiffs' Brief ("Pb") refers to two different clients with the initials "J.H." See Pb 9, n. 10.

- a. I referred "J.H." (Bensman Exh. 17 at JIFGA-00036091-92) to Robert Vazzo years before the Permanent Injunction was entered in 2015.
- b. I did not refer "J.H." (Bensman Exh. 17 at JIFGA-00039944-45) to Vazzo.
4. I did not refer "R.R." (Pb 9, n. 10) to Vazzo.
5. I did not refer "I.M." (Pb 9, n. 10) to Robert Morgan.
6. The Nefesh listserv and JNARS listserv (*see* Pb 10) both provide valuable information to mental health professionals, and only a small percentage of the postings on those listservs concern potential client referrals. Membership in those organizations is not limited to mental health professionals.
7. The referrals that I made in Bensman Exh. 23 ("Suggestions from phone call") were to a married couple ("GA" and "JA") for couples' therapy, and not to address their sexual orientation.
8. "S.M." (*see* Bensman Exhs. 24, 37, 38) is from New York.
9. I travel extensively and was not in New Jersey when many of the emails referenced in Plaintiffs' Brief were sent. In the three years following the entry of the Permanent Injunction, I took more than 30 separate multi-day trips outside the State of New Jersey. For example:
  - a. On December 31, 2015, when Bensman Exhibits 11 and 13 were sent, I was in New York housesitting for my daughter.
  - b. On April 9-10, 2017, when Bensman Exhibits 37-38 were sent, I was in Maryland for Passover.
  - c. On July 16, 2017, when Bensman Exhibit 29 was sent, I was on vacation in Kentucky.

10. I do not know the person identified as "E.C." See Bensman Exh. 37 at -02. I was not acquainted with E.C. I do not know if I ever met him or spoke to him. I did not then (and do not now) know if E.C. was from New Jersey. I did not solicit E.C. to attend the JIM weekend. That weekend was a series of group events, and I have no recollection of any personal interaction with E.C.

11. Following the May 2018 court hearing, JIFGA refunded all of the therapy fees that JIFGA had received. Specifically, on June 6, 2018, JIFGA refunded more than \$50,000 — \$46,042.68 to nine different clients plus \$4,282.50 to Morgan and Vazzo. True copies of those checks, with the corresponding cover letters, are attached hereto as Exhibit A (with identifying information redacted).

12. JIFGA received a single payment from Client 8's mother — \$260.00 on or about July 8, 2016. A true copy of that \$260.00 payment is attached hereto as Exhibit B (with identifying information redacted). Of that \$260.00, \$85.00 was returned 3 days later, on July 11, 2016. A true copy is attached hereto as Exhibit C (with identifying information redacted). The balance — \$175.00 — was refunded by JIFGA to Client 8's mother on June 6, 2018. A true copy of that \$175.00 check, with the corresponding cover letter, is attached hereto as Exhibit D (with identifying information redacted). Thus, JIFGA refunded all of the money it received from Client 8.

13. Some of Client 8's therapy fees were paid directly to Vazzo. To the extent that JIFGA received referral fees from Vazzo and Morgan, JIFGA refunded those fees to Vazzo and Morgan. See Exhibit A.

14. In their 2018 motion, Plaintiffs complained that *JIFGA* had received therapy fees from JONAH clients. As a result of that allegation, I instructed JIFGA's bookkeeper to review


*JIFGA's* financial records to determine the extent of those payments. Plaintiffs did not allege, however, that *JONAH* had received therapy fees after the entry of the Permanent Injunction and, at that time (2018), I did not recall that *JONAH* had received therapy fees in the months between the entry of the Permanent Injunction (in December 2015) and *JONAH's* dissolution (in August 2016). I therefore did not instruct the bookkeeper to review *JONAH's* financial records at that time.

15. When Plaintiffs' motion was filed on March 27, 2019, and in light of the allegation in Plaintiffs' Brief that *JIFGA* had miscalculated the refund to Client 8, *JIFGA* undertook to review its financial records a second time. In the course of that re-review, I discovered that, in addition to the fees received by *JIFGA* after the Permanent Injunction was entered, *JONAH* had also received some therapy fees in the few months after the Permanent Injunction was entered and before the dissolution of *JONAH*. Specifically, from the date of the Permanent Injunction through June 2016, *JONAH* received \$14,071.00 from eleven clients (including \$1,225.00 from Client 8's mother) plus \$822.50 from Vazzo and Morgan. All eleven of those clients were clients of *JONAH* prior to 2016.

16. Those fees were refunded in their entirety on April 25, 2019 (within 30 days of Defendants' receipt of Plaintiffs' Brief). True copies of those checks, with the corresponding cover letters, are attached hereto as Exhibit E (with identifying information redacted). Page 2 of Exhibit E reflects a refund to B.A. Page 4 of Exhibit E reflects a refund to H.E., including the fees for N.S. that were paid by H.E.

17. The fees for S.M. (*see* Pb 19, n.21) were never received and therefore never refunded.


