**JOINT MOTION FOR AN ORDER AMENDING THE BRIEFING
SCHEDULE ON PLAINTIFF'S MOTION TO STRIKE (DKT. 192)**

The parties in this action jointly move for an order amending the briefing schedule on Plaintiff's Motion to Strike the Declaration and Exclude Testimony of Michelle Ostrander, Ph.D (Dkt. 192 (Motion to Strike).) The grounds for this motion are as follows.

On June 4, 2019, Plaintiffs filed the Motion to Strike. The Court set a deadline of June 18, 2019 for Defendants to file their brief in opposition, and another deadline of June 25, 2019 for Plaintiffs to file their reply.

Due to significant workload and planned and unplanned absences from the office of counsel for Defendants during the time to draft their response, it will be very difficult for Defendants to meet this June 18, 2019 filing deadline.

As a result, Defendants respectfully seek an extension of time of ten (10) days to file their response, thereby setting a new deadline of June 28, 2019. In turn, Plaintiffs seek a deadline of July 12, 2019 to file their reply.
