PLAINTIFF’S OBJECTIONS TO DEFENDANTS’ TRIAL EXHIBIT LIST

Pursuant to this Court’s order in *Harrison*, see ECF No. 63, Plaintiffs make the following objections to the proposed trial exhibits identified by Defendants on June 5, 2019. Plaintiffs reserve the right to amend or modify any of the objections set forth below on the basis of any stipulation entered into by the Parties; corrections, revisions, or other changes to the underlying exhibits; any order from this Court on outstanding motions; as the facts of the case are developed through trial; and any ruling from the Court impacting admissibility. Plaintiffs reserve the right to file motions *in limine* with respect to any exhibits identified by Defendants.

Plaintiffs note that many of Defendants’ proposed trial exhibits include personally-identifying information including social security numbers. Such information should be redacted before any such exhibits is offered into evidence in a public form. Moreover, two of Plaintiffs have been proceeding anonymously in the *Roe v. Shanahan* case. Plaintiffs Roe and Voe object

to offering any document into evidence which does not have appropriate redactions sufficient to preserve their anonymity.
