**DEFENDANTS' OBJECTIONS TO PLAINTIFFS'
FIRST SUPPLEMENTAL EXHIBIT LIST**

Defendants hereby lodge their objections to Plaintiff's First Supplemental Exhibit List.

Harrison v. Esper, No. 1:18-cv-641, Dkt. 196; *Roe v. Esper*, No. 1:18-cv-1565, Dkt. 159.

These objections are based on the present status of the above-captioned matters.

Defendants do not waive future objections in the event that any exhibit becomes irrelevant because of this Court's ruling on any potential motion for summary judgment or motion *in limine* to be filed

in advance of trial, and by not objecting at this stage Defendants do not concede that certain topics are relevant to the claims remaining against Defendants.

Additionally, several of these objections are only to the introduction and admission of the exhibit as affirmative evidence, and Defendants reserve the right to utilize and admit any particular exhibit as impeachment if necessary.

Plaintiffs have identified several exhibits in their exhibit list that appear to be chains of electronic mail messages, which it appears they intend to introduce into evidence in their entirety. Defendants' objections to such exhibits reflect this understanding. However, to the extent that Plaintiffs intend to introduce only certain messages within the overall chain, Defendants reserve the right to interpose amended objections (especially those presented on hearsay grounds). Similarly, Defendants' objections to compilations of exhibits may relate only to certain documents within the compendium or incomplete exhibit, and not necessarily to every document included within the compendium or, where a partial document was included in the exhibit, to the complete document.

Defendants reserve the right to waive any of these objections, to interpose objections based upon authentication, foundation, and—depending on usage—hearsay, and to add to these objections based upon any ruling this Court might enter on the parties' respective motions for summary judgment and/or motions *in limine*.

In addition, Defendants further object to these exhibits as outside the proper scope of judicial review. For the reasons previously identified by defendants in opposition to Plaintiffs' motions for preliminary injunction, *Harrison v. Shanahan*, No. 1:18-cv-641, ECF Dkt. 40, at 20-30, *Roe v. Shanahan*, No. 1:18-cv-1565, ECF Dkt. 50, at 9-10, 21-25, Plaintiffs' constitutional challenges properly are governed by rational basis review. The Supreme Court has made abundantly clear that a legislative choice subject to the rational basis test "is not subject to courtroom fact-finding and may be based on rational speculation unsupported by evidence or empirical data." *FCC v. Beach*

Commc'ns, 508 U.S. 307, 315 (1993). The proper analysis instead asks whether the agency “rationally could have believed” that the conditions of the regulation would promote its objective. *W. & S. Life Ins. Co. v. State Bd.*, 451 U.S. 648, 671-72 (1981) (emphasis in original). Rational basis review, moreover, “is not a license for courts to judge the wisdom, fairness, or logic of legislative choices.” *Beach Commc'ns*, 508 U.S. at 313. Rather, “those challenging the legislative judgment must convince the court that the legislative facts on which the classification is apparently based could not reasonably be conceived to be true by the governmental decisionmaker.” *Vance v. Bradley*, 440 U.S. 93, 111 (1979). .

Defendants also reserve an objection to the presentation of evidence that is outside of the administrative record. The Department of Defense’s and Department of the Air Force’s administrative processes that resulted in final agency action are supported by administrative records. In making the determination whether those policies are “contrary to constitutional right,” 5 U.S.C. § 706(2)(B), the Court “shall review the whole record,” *id.* § 706. The Court’s review is therefore limited to “the full administrative record that was before the Secretary at the time he made his decision.” *Citizens to Preserve Overton Park, Inc. v. Volpe*, 401 U.S. 402, 420 (1971).

Further, as recently emphasized by the D.C. Circuit in a challenge to another military personnel policy, the Court must give great deference to the judgment of military officials. *Doe 2 v. Shanahan*, 755 F. App’x 19, 24–25 (D.C. Cir. 2019) (per curiam). Such deference means that neither the Plaintiffs, Plaintiffs’ witnesses, nor the Court may undertake an independent evaluation of the evidence. *Rostker v. Goldberg*, 453 U.S. 57, 81 (1981) (“In relying on this testimony . . . the District Court palpably exceeded its authority when it ignored Congress’ considered response to this line of reasoning.”); *id.* at 82-83 (“The District Court was quite wrong in undertaking an independent evaluation of this evidence.”); *Goldman v. Weinberger*, 475 U.S. 501, 508 (1986) (“[W]hether or not expert witnesses may feel that religious exceptions to [the challenged military regulation] are

desirable is quite beside the point.”); *see also Winter v. Nat. Res. Def. Council, Inc.*, 555 U.S. 7, 25 (2008) (“We accept these officers’ assertions [that a certain practice] is of the utmost importance to the Navy and the Nation.”); *Doe 2*, 917 F.3d 694 at 737 (Williams, J., concurring) (noting the court’s role in evaluating military policy is so circumscribed that extra-record evidence and discovery is “quite beside the point” (quoting *Goldman v. Weinberger*, 475 U.S. 503, 509 (1986))). Rather, as the Supreme Court emphasized in *Trump v. Hawaii*, 138 S. Ct. 2392, 2420 (2018), the Court’s review of the Department of Defense, Department of the Army, and Department of the Air Force policies must focus on the stated justifications for the policies.

Moreover, the Administrative Procedure Act “confines judicial review of executive branch decisions to the administrative record of proceedings before the pertinent agency. As such, there can be no genuine issue of material fact in an APA action. . . .” *Shipbuilders Council of Am. v. U.S. Dep’t of Homeland Sec.*, 770 F.Supp.2d 793, 802 (E.D.Va.2011) (citations omitted). With respect to such claims, “the function of the district court is to determine whether or not as a matter of law the evidence in the administrative record permitted the agency to make the decision it did.” *Id.* (internal quotation marks omitted).
