STIPULATED MOTION TO REDACT

Plaintiff Russell B. Toomey (“Plaintiff”) filed his Complaint (DE #1) on January 23, 2019. Plaintiff inadvertently left his home address in Exhibit G to the Complaint, DE #1-3, on page 72. Plaintiff now seeks to redact this information to protect his security and that of his family. Transgender people are at risk for violence and there is no compelling interest in the public knowing Plaintiff’s home address.

Plaintiff’s counsel has conferred with counsel for all Defendants. Defendants’ counsel agrees and stipulates to the request to redact Plaintiff’s home address.

For the foregoing reasons, the parties request that Plaintiff be allowed to redact his home address from Exhibit G to the Complaint.
