1 Pursuant to this Court’s Order Re Stipulated Request and Briefing Schedule, Dkt. No. 66,
2 and by analogy to Federal Rule of Appellate Procedure 29(b), amici curiae American
3 Association of Pro-Life Obstetricians & Gynecologists, American College of Pediatricians,
4 Catholic Medical Association, and National Catholic Bioethics Center hereby submit this
5 Unopposed Motion for Leave to File an Amici Curiae Brief in support of Defendants’ Motion for
6 Summary Judgment.

7 **INTEREST OF AMICUS CURIAE**

8 American Association of Pro-Life Obstetricians & Gynecologists (AAPLOG) is a non-
9 profit professional medical organization comprising more than 4,000 obstetrician–gynecologist
10 members and associates. AAPLOG held the title of “special interest group” within the American
11 College/Congress of Obstetricians and Gynecologists (ACOG) from 1973 to 2013, until this
12 designation was discontinued by ACOG. AAPLOG is concerned about the quality of care
13 provided to pregnant women and the potential long-term adverse consequences of abortion on
14 women’s health. Accordingly, AAPLOG explores data from around the world regarding
15 abortion-associated complications, such as depression, substance abuse, suicide, subsequent
16 preterm birth, and *placenta previa*, in order to provide the general public, medical colleagues,
17 and others with a realistic understanding of abortion-related health risks.

18 American College of Pediatricians (ACPeds) is a national non-profit organization of
19 pediatricians and other healthcare professionals, formed in 2002 and dedicated to the health and
20 well-being of children. ACPeds’s mission is to enable all children to reach their optimal physical
21 and emotional health and well-being. To this end, ACPeds has written a number of position
22 statements on matters unique to children and continues to produce sound policy based upon the
23 best available research to assist parents and society in caring for children. Membership is open
24 to qualifying healthcare professionals who share the ACPeds’ mission, vision, and values.
25 ACPeds currently has members in forty-seven states, as well as in several countries outside of
26 the United States.

27 The Catholic Medical Association (CMA) is a national, physician-led community of
28 healthcare professionals that informs, organizes, and inspires its members, in steadfast fidelity to

1 the teachings of the Catholic Church, to uphold the principles of the Catholic faith in the science
2 and practice of medicine.

3 The National Catholic Bioethics Center (NCBC) is a non-profit research and educational
4 institute committed to applying the moral teachings of the Catholic Church to ethical issues
5 arising in health care and the life sciences. NCBC administers a certification program in
6 bioethics in collaboration with two graduate programs providing graduate degrees to our dually
7 enrolled students concentrating in bioethics. It also provides consultations to institutions and
8 individuals seeking its opinion on the appropriate application of Catholic moral teachings to
9 these ethical issues, impacting human rights of vulnerable populations and conscience rights of
10 their providers. NCBC has 2,500 members (many of whom are institutional members
11 representing thousands of persons) throughout the United States. Increasingly, NCBC is
12 contacted by members and non-members alike seeking consultation on the increasing coercion to
13 violate deeply held religious beliefs or moral values in the delivery of health care.

14 **REASONS WHY THE MOTION SHOULD BE GRANTED**

15 “The ‘classic role’ of amicus curiae is to assist a court in a case of public interest by
16 ‘supplementing the efforts of counsel, and drawing the court’s attention to law that escaped
17 consideration.’” *Cal. by & through Becerra v. U.S. Dep’t of the Interior*, 381 F. Supp. 3d 1153,
18 1163–64 (N.D. Cal. 2019) (granting motion for leave to file amicus brief) (quoting *Miller-Wohl*
19 *Co. v. Comm’r of Labor & Indus. State of Mont.*, 694 F.2d 203, 204 (9th Cir. 1982)). As this
20 Court has recognized, “[w]hether to allow Amici to file a brief is solely within the Court’s
21 discretion, and generally courts have ‘exercised great liberality’ in permitting amicus briefs.” *Id.*
22 at 1164 (citation omitted). This Court has accepted amicus briefs to assist the Court in significant
23 cases. *See, e.g., Moore v. Verizon Commc’ns Inc.*, No. C 09-1823 SBA, 2013 WL 450365, at *9
24 (N.D. Cal. Feb. 5, 2013) (concluding that “an amicus brief is appropriate because it will assist
25 the Court in fulfilling its obligation to closely scrutinize [the issue]”); *In re Network Assocs.,*
26 *Inc., Sec. Litig.*, 76 F. Supp. 2d 1017, 1026 (N.D. Cal. 1999) (citing an amicus brief favorably
27 and noting that the Court “invit[ed]” amicus participation).

1 To be granted leave, amici “must merely make a showing that [their] participation is
2 useful or otherwise desirable to the court.” *Cal. by & through Becerra*, 381 F. Supp. 3d at 1164
3 (citation omitted); *see also Hoptowit v. Ray*, 682 F.2d 1237, 1260 (9th Cir. 1982) (“The district
4 court has broad discretion” to appoint amici curiae.). Consequently, “[t]he scope of amicus briefs
5 ... should be limited to the issues raised by the parties.” *Cal. by & through Becerra*, 381 F. Supp.
6 3d at 1164. The proposed brief satisfies these criteria.

7 Amici AAPLOG, ACPeds, CMA, and NCBC are able and well-suited to help this Court
8 toward right answers in a case involving complex matters of interrelated federal laws and
9 constitutional law, which have generated numerous legal disputes affecting Amici’s thousands of
10 members. Amici’s members are among the health care professionals who will be most affected—
11 and protected—by the HHS Conscience Rule. Accordingly, Amici are uniquely situated to
12 inform the Court of specific ways in which the Rule complements existing medical conscience
13 laws, to provide meaningful protections for medical practitioners. Amici can also describe to the
14 Court specific instances in which existing laws were inadequate to effectively protect medical
15 conscience rights, and how the Rule would avoid such rights violations and needless litigation
16 going forward.

17 In addition, Amici would explain to this Court the relevance of several Supreme Court
18 cases recognizing conscience rights in health care. These Supreme Court decisions discuss the
19 dilemmas that Amici’s members face in practicing medicine, and they portend the need for the
20 Conscience Rule, if conscience rights are going to be properly protected in the field of medicine.

21 CONCLUSION

22 The direct stake that members of AAPLOG, ACPEds, CMA, and NCBC—and like-
23 minded health care professionals—have in ensuring that constitutional rights of conscience are
24 adequately protected justifies the filing of the proposed amici curiae brief. Amici therefore
25 respectfully request that this Court grant their unopposed motion to file a timely amici curiae
26 brief.

Identity and Interest of Amici

1
2 The American Association of Pro-Life Obstetricians & Gynecologists (AAPLOG) is a
3 non-profit professional medical organization comprising more than 4,000 obstetrician-
4 gynecologist members and associates. AAPLOG held the title of “special interest group” within
5 the American College/Congress of Obstetricians and Gynecologists (ACOG) from 1973 to 2013,
6 until this designation was discontinued by ACOG. AAPLOG is concerned about the quality of
7 care provided to pregnant women and the potential long-term adverse consequences of abortion
8 on women’s health. Accordingly, AAPLOG explores data from around the world regarding
9 abortion-associated complications, such as depression, substance abuse, suicide, subsequent
10 preterm birth, and *placenta previa*, in order to provide the general public, medical colleagues,
11 and others with a realistic understanding of abortion-related health risks.

12 The American College of Pediatricians (ACPeds) is a national non-profit organization of
13 pediatricians and other health care professionals, formed in 2002 and dedicated to the health and
14 well-being of children. ACPeds’s mission is to enable all children to reach their optimal physical
15 and emotional health and well-being. To this end, ACPeds has written a number of position
16 statements on matters unique to children and continues to produce sound policy based upon the
17 best available research to assist parents and society in caring for children. Membership is open
18 to qualifying health care professionals who share the ACPeds’s mission, vision, and values.
19 ACPeds currently has members in forty-seven states, as well as in several countries outside of
20 the United States.

21 The Catholic Medical Association (CMA) is a national, physician-led community of
22 health care professionals that informs, organizes, and inspires its members, in steadfast fidelity to
23 the teachings of the Catholic Church, to uphold the principles of the Catholic faith in the science
24 and practice of medicine.

25 The National Catholic Bioethics Center (NCBC) is a non-profit research and educational
26 institute committed to applying the moral teachings of the Catholic Church to ethical issues
27 arising in health care and the life sciences. NCBC administers a certification program in
28 bioethics in collaboration with two graduate programs providing graduate degrees to our dually

1 enrolled students concentrating in bioethics. It also provides consultations to institutions and
 2 individuals seeking its opinion on the appropriate application of Catholic moral teachings to
 3 these ethical issues, impacting human rights of vulnerable populations and conscience rights of
 4 their providers. NCBC has 2,500 members (many of whom are institutional members
 5 representing thousands of persons) throughout the United States. Increasingly, the Center is
 6 contacted by members and non-members alike seeking consultation on the increasing coercion to
 7 violate deeply held religious beliefs or moral values in the delivery of health care.

8 **Introduction and Summary**

9 Rights of conscience are at the core of constitutional freedoms and are, in the words of
 10 James Madison, “unalienable.”¹ Conscience is also at the heart of what motivates many who
 11 enter the medical field, a profession full of individuals who dedicate their lives to healing and
 12 doing no harm. When these conscience rights clash (as they sometimes do) with various rights
 13 asserted by others, the individual conscience—“the most sacred of all property”²—must not be
 14 sacrificed in the name of business interests, political goals, or the convenience of others.

15 Despite clear constitutional principles assuring the sanctity of conscience, political
 16 interest groups lobby to prevent the exercise of conscience rights by people holding certain
 17 disfavored religious or moral beliefs. Federal and state legislation have provided specific
 18 protections for medical conscience rights, but those have proven weak or ignored.

19 Conscience rights are not limited based on one’s professional status. Plaintiffs’ argument
 20 that too many health care workers’ consciences would be protected under the HHS Conscience
 21 Rule shows a misunderstanding of the fundamental rights we have historically protected—
 22 beginning with the guarantees of First Amendment. Individual conscience rights are paramount,
 23 regardless of a person’s job title or role. Decades of Supreme Court caselaw teach that
 24 complicity in an act creates an unconstitutional conscience burden.

1 Nor are conscience rights limited to particular aspects of health care. Plaintiffs’
 2 suggestion that conscientious objections should be largely limited to “abortion and sterilization,”
 3 *see* CA Compl. ¶ 66, CCSF Compl. ¶ 32, ignores a serious reason the Rule is necessary: there are
 4 many significant controversial aspects of medicine that implicate ethical quandaries. The
 5 government may not pick and choose which particular views or topics deserve protection.³

6 The purpose and effect of the Rule is to meaningfully effectuate the laws that Plaintiffs
 7 claim they adhere to. Specific examples show that existing legal protections for medical
 8 conscience rights have not been enough to prevent egregious violations or to stave off efforts to
 9 force moral conformity. Millions of American health care workers will have their rights
 10 safeguarded by the fortified protections of the Conscience Rule.

11 **I. Longstanding foundational constitutional principles support the legality of the Rule.**

12 The Conscience Rule is a straightforward application of the basic conscience rights that
 13 have been secured since the inception of this nation. The American Republic was established to
 14 be a refuge for conscience;⁴ as Samuel Adams put it, “freedom of thought and the right of private
 15 judgment in matters of conscience direct their course to this happy country as their last asylum.”⁵
 16 Thomas Jefferson agreed that conscience “could not [be] submit[ted]” to governmental oversight
 17 or authority.⁶

18 Liberty of conscience was the cornerstone of the Constitution. As Jefferson put it, “[n]o
 19 provision in our Constitution ought to be dearer to man than that which protects the rights of
 20 conscience against the enterprises of the civil authority.”⁷ Government infringement on

1 conscience was intolerable and inconceivable to the Founders. Shortly before the Bill of Rights
 2 was adopted, George Washington insisted that if the “Government might ever be so administered
 3 as to render the liberty of conscience insecure,” he would be the first “to establish effectual
 4 barriers against the horrors of spiritual tyranny and every species of religious persecution.”⁸ John
 5 Jay, the first Chief Justice of the Supreme Court, agreed that conscience protections are a
 6 constitutional guarantee: “Adequate security [under our Constitution] is given to the rights of
 7 conscience and private judgment. They are by nature subject to no control but that of Deity.”
 8 And Joseph Story, one of our nation’s most prominent Supreme Court justices, said that “rights
 9 of conscience are ... beyond the just reach of any human power. They ... [must] not be
 10 encroached upon by human authority.”⁹

11 The First Amendment itself protects a cluster of rights that depend on freedom of mind.
 12 Freedom of speech, freedom of religious exercise, and freedom of assembly are concerned with
 13 guaranteeing that individuals can live consistently with their own thoughts and beliefs. This same
 14 right of conscience has also been essential to the practice of medicine for millennia, as evidenced
 15 by the Hippocratic Oath’s reverence for human life, and medicine’s status as an autonomous
 16 profession concerned with doing right and avoiding wrong.¹⁰

17 In the context of health care, the U.S. Supreme Court has repeatedly acknowledged the
 18 sanctity of medical conscience rights. In *Roe v. Wade*, for example, the Supreme Court cited a
 19 resolution of the American Medical Association confirming that “no party to the procedure
 20 should be required to violate personally held moral principles. ... Neither physician, hospital,
 21 nor hospital personnel shall be required to perform any act violative of personally-held moral

1 principles.” 410 U.S. 113, 143 n.38 (1973). The same day, the Supreme Court decided a
2 companion case, *Doe v. Bolton*, and noted with approval that the statute at issue expressly
3 protected conscience, allowing “a physician or any other employee ... the right to refrain, for
4 moral or religious reasons, from participating in the abortion procedure.” 410 U.S. 179, 197–98
5 (1973). This, the Court said, “afford[ed] appropriate protection to the individual and to the
6 denominational hospital.” *Id.* at 198.

7 The Supreme Court was soon confronted with problems stemming from conscience and
8 the doors *Roe v. Wade* opened. Cases like *Maher v. Roe* and *Harris v. McRae* confirmed that
9 individuals may, through the states, effect policies reflecting “a value judgment favoring
10 childbirth over abortion,” *Maher*, 432 U.S. 464, 474 (1977), and be free from forced
11 subsidization of abortion through taxpayer dollars, *McRae*, 448 U.S. 297, 318 (1980).

12 The Court in *McRae* gave careful consideration to conscience concerns, and even the
13 plaintiffs—a group of women wanting the government to fund their abortions—acknowledged
14 that whether to have an abortion “is a determination which must be ultimately and absolutely
15 entrusted to the conscience of the individual before God.” 448 U.S. at 321. Surely the same is
16 true for whether to assist in an abortion.

17 In *Planned Parenthood v. Casey*, 505 U.S. 833 (1992), conscience issues came up again.
18 The plurality opinion began with a reminder that what was decided in *Roe* as a legal matter is in
19 fact a much bigger question of conscience that cannot be settled or ignored:

20 Men and women of good conscience can disagree, and we suppose some always
21 shall disagree, about the profound moral and spiritual implications of terminating
22 a pregnancy, even in its earliest stage. Some of us as individuals find abortion
23 offensive to our most basic principles of morality.

24 *Id.* at 850 (plurality op.).

25 The Court explained that “the abortion decision originate[s] within the zone of
26 conscience and belief.” *Id.* at 852. Then the Court highlighted serious questions of conscience *for*
27 *all Americans* implicated by abortion: “Abortion is a unique act. It is an act *fraught with*
28 *consequences for others*: for the woman who must live with the implications of her decision; for
the persons who *perform and assist in* the procedure; for the spouse, family, and society which

1 must confront the knowledge that these procedures exist, procedures some deem nothing short of
2 an act of violence against innocent human life; and, depending on one’s beliefs, consequences
3 for the life or potential life that is aborted.” *Id.* at 852.

4 It is critical for the law to be clear about what happens in these moral, ethical, religious,
5 and philosophical dilemmas. The Rule does just that.

6 **II. The Conscience Rule buttresses legal protections long established by Congress as the**
7 **will of the people but not always effectively enforced.**

8 Congress has repeatedly passed laws demonstrating a bipartisan intent that health care
9 professionals not be coerced into violating their beliefs. The potential threat to conscience rights
10 triggered by *Roe* set off a chain of federal and state laws enacted to protect individuals and
11 institutions that objected to participating in abortion. The first of these laws, the Church
12 Amendments, 42 U.S.C. § 300a–7 et seq., were enacted in the 1970s to provide protections for
13 health care professionals who object to performing abortions, sterilizations, and other procedures
14 based on their moral convictions or religious beliefs.¹¹

15 But despite the Supreme Court’s pronouncements and the protections of the Church
16 Amendments, public medical schools began pressuring students to undergo mandatory abortion
17 training. In 1996, a bipartisan Congress again defended conscience rights with the Coats–Snowe
18 Amendments, 42 U.S.C. § 238n, prohibiting the federal government and any state or local
19 government receiving federal funds from discriminating against health care professionals based
20 on a conscientious refusal to participate in abortions, abortion training, or abortion referrals.

21 But as attacks on conscience continued, a bipartisan Congress again saw a need to
22 intervene, passing the 2004 Weldon Amendment, Pub. L. No. 108–447, an appropriations rider
23 prohibiting funds from the Departments of Health, Labor, or Education from flowing to any

1 federal, state, or local government or program that discriminates against individual or
 2 institutional health care providers for their refusal to “provide, pay for, provide coverage for, or
 3 refer for abortions.” *Id.* at Tit. V, § 508(d)(1). This conscience protection was met with great
 4 resistance and lawsuits by abortion advocates, but courts rejected the challenges, and the Weldon
 5 Amendment has been renewed in each subsequent budget bill.

6 During the past four decades, most states have enacted their own conscience protections,
 7 modeled primarily after the Church Amendments but varied in terms of who and what is
 8 covered. Enforcement, however, has been inconsistent, in part because of deficient legal
 9 enforcement mechanisms.

10 Taken together, these laws show that at both the state and national level, the legislative
 11 intent is to protect medical professionals’ conscience rights. But these laws are missing
 12 something the Conscience Rule provides: clear methods to ensure that they are enforced. *See*
 13 *infra* Section V. If, as Plaintiffs claim, they “fully compl[y] with all of these [health care
 14 conscience] laws,” CCSF Compl. ¶ 32, then they should have no problem complying with the
 15 Rule that simply provides mechanisms for those laws to be meaningfully enforced.

16 **III. Recent attacks on certain beliefs show that conscience rights are still very much under**
 17 **siege.**

18 Unfortunately, threats persist. Professional organizations have taken aim at health care
 19 professionals whose exercise of conscience do not “conform[] to their own agenda.”¹² Opponents
 20 to conscience in medicine, such as Plaintiffs, claim it “obstruct[s] access to goods and
 21 services,”¹³ and constitutes an abdication of the medical practitioner’s duty.¹⁴ Some argue that
 22 physicians with moral objections to certain procedures should simply avoid practicing in a field
 23

1 that implicates their objections.¹⁵ Others conclude that “health care professionals should be
 2 admonished that conscientious objections based on personal beliefs, as opposed to professional
 3 ethics, will entail consequences.”¹⁶ A group of philosophers and bioethicists recently went
 4 further, proposing that medical practitioners who exercise freedom of conscience “should be
 5 required to compensate society and the health system for their failure to fulfil their professional
 6 obligations.”¹⁷ Still others have claimed that “[a] doctor’s conscience has little place in the
 7 delivery of modern medical care.”¹⁸

8 Perhaps most alarming, even professional medical associations now question the role of
 9 conscience in the provision of medical care. The Committee on Ethics of the American College
 10 of Obstetricians and Gynecologists has opined that physicians have a duty to either refer for
 11 abortion and other related procedures or, in the alternative, when such referral is not feasible,
 12 “provide medically indicated and requested care regardless of the provider’s personal moral
 13 objections.”¹⁹ After the Bush Administration sought to bolster federal medical conscience
 14 protections in 2008, the American Medical Association and other professional groups submitted
 15 comments in opposition, claiming that “[d]octors who follow their consciences might violate
 16 their ‘paramount responsibility and commitment to serving the needs of their patients.’”²⁰

17 States too have shown disregard for protecting the conscience rights of medical
 18 practitioners. In response to a prior federal attempt to shore up conscience protections, thirteen
 19

1 state attorneys general signed a letter denouncing the regulations,²¹ and seven states later filed
2 suit to block them.²² More recently, Illinois amended its Healthcare Right of Conscience Act to
3 require medical practitioners and institutions to provide abortion referrals.²³ Vermont regulatory
4 agencies attempted to construe Act 39, the state’s recently enacted assisted-suicide law, to
5 *require* medical professionals to counsel (or refer for counseling) their terminal patients for
6 physician-assisted suicide.²⁴ And California passed AB 775, requiring faith-based licensed
7 medical centers offering free services to pregnant women to post signs advertising that California
8 provides free or low-cost abortions.²⁵

9 Extant federal conscience protections have proven incapable of combatting this
10 pernicious trend, principally because, unlike the Rule, they lack meaningful enforcement
11 mechanisms and frequently cover only a limited range of procedures and health care personnel.

12 **IV. The Rule could have prevented many recent violations.**

13 The travails of individual medical practitioners show that federal conscience protections,
14 although many in number and often long on the statute books, have been inadequate to protect
15 the very rights to conscience they were crafted to vindicate. Had the Conscience Rule been in
16 place, it is likely that few of these gut-wrenching dilemmas, much less the burdensome litigation,
17 would have occurred.

1 **A. Cathy Cenzone-DeCarlo was forced to participate in abortion.**

2 Cathy Cenzone-DeCarlo is a devout Catholic and a surgical nurse at Mount Sinai Hospital
3 in New York City.²⁶ Because of her religious belief that abortion is the unwarranted taking of a
4 human life, DeCarlo told Mount Sinai that she is unwilling to participate in abortion, and
5 completed paperwork to that effect upon hiring. That agreement was ignored when hospital
6 officials compelled DeCarlo to assist in the abortion of a 22-week-old preborn baby. Hospital
7 officials threatened DeCarlo with charges of “insubordination and patient abandonment” if she
8 did not immediately assist in the abortion, even though the case did not involve emergency
9 circumstances.²⁷ Despite federal protections designed precisely to protect her in this situation,
10 DeCarlo was unable to convince her supervisors to relent. Faced with losing her job or her
11 nursing license, DeCarlo was compelled to assist in the abortion. When she filed suit against the
12 hospital, the action was dismissed because the court found that she had no private right of
13 action.²⁸ DeCarlo was instead beholden to the federal bureaucracy to pursue the complaint her
14 attorneys filed with HHS, which finally investigated the incident after a delay but did not
ultimately resolve it.

15 Although Mount Sinai eventually revised its policies to respect conscience rights,
16 DeCarlo’s ordeal inflicted emotional and psychological trauma that have left lasting scars. Her
17 crisis shows that federal conscience protections—even when clearly applicable—will do little to
18 prevent abuses, without meaningful enforcement mechanisms and a knowledge on the part of
19 health care facilities that HHS will enforce regulations swiftly and consistently.

20 **B. The Stormans were required to distribute abortion-causing drugs.**

21 The Stormans family owns and operates Ralph’s Thriftway, a fourth-generation grocery
22 and pharmacy in Olympia, Washington.²⁹ As Christians, they object to destroying human life.
23 They refrain from stocking abortifacient drugs in their pharmacy, because such medications can
24 kill an embryo. If the Stormans receive a request for abortifacients, they typically refer customers

1 to nearby pharmacies that regularly stock and dispense them—all within five miles of Ralph’s.
2 Such referrals are commonplace in the pharmacy practice.

3 In 2007, the Washington State Pharmacy Commission, stacked with abortion advocates,
4 enacted a rule prohibiting conscience-based referrals. The Stormans had to sue to protect their
5 conscience rights, and after years of litigation, a federal district court ruled that the new state
6 regulations violated the Free Exercise Clause.³⁰ But the Ninth Circuit reversed the trial court, and
7 the United States Supreme Court declined to hear the appeal, letting stand the nation’s only state
8 ban on conscience referrals by pharmacists.³¹

9 This case signals that states, along with advocacy groups and even medical associations,
10 will sacrifice conscience in exchange for perceived political gain. It also shows that prior federal
11 protections did not protect such abuses, even where intended to. The Rule prevents coercion to
12 violate one’s conscience by referring for any lawful procedure.

12 **C. Trinity Health was sued for not performing abortions.**

13 Trinity Health operates more than 200 facilities throughout the U.S., and is particularly
14 dedicated to serving impoverished communities.³² It provides health care in accordance with
15 Roman Catholic teaching, hewing to the Ethical and Religious Directives issued by the United
16 States Conference of Catholic Bishops.³³ Those directives state that “[a]bortion (that is, the
17 directly intended termination of pregnancy before viability or the directly intended destruction of
18 a viable fetus) is never permitted.”³⁴ The same directives permit Catholic hospitals to take steps

1 to save the life of the mother, even if such steps may unintentionally and indirectly result in harm
2 to her unborn baby.³⁵

3 The ACLU sued Trinity Health, claiming that these convictions present a threat to
4 women who might—for “health reasons”—need an abortion and might only have access to a
5 Trinity facility. The ACLU alleged that Trinity Health’s refusal to intentionally perform
6 abortions violated the Emergency Medical Treatment and Active Labor Act and the
7 Rehabilitation Act, and sought to compel Trinity Health to reject its Catholic beliefs by
8 performing abortions.³⁶ A federal district court dismissed the case for lack of standing, but
9 attacks on institutions like Trinity Health would likely continue unabated absent stronger
10 conscience protections, like the Rule provides. The Conscience Rule’s penalties for
11 noncompliance should prevent frivolous claims like the one against Trinity Health from
12 detracting from the saving work of these institutions going forward.

13 **D. The need for the Rule is widespread and increasing.**

14 These incidents are not isolated. Gallup and Pew polling consistently show that
15 somewhere between 38–53% of Americans believe abortion should be illegal in most or all
16 circumstances.³⁷ These individuals do not want to facilitate something that they believe should

1 be outlawed. They may well agree with Amici that “[p]regnancy is not a disease, and the killing
2 of human beings in utero is not medical care.”³⁸

3 Other polling shows that 6 in 10 U.S. adults profess a belief in the Bible,³⁹ which states
4 that humans are created as one of two sexes: male or female.⁴⁰ These individuals are likely to
5 find it morally unacceptable to, for example, inject puberty blockers and cross-sex hormones into
6 adolescents as a way to “treat” gender dysphoria.⁴¹ In fact, a group of Christian health care
7 providers recently had to seek and obtain relief in federal court when a new regulation
8 “require[d] them to perform ... gender transitions ..., regardless of their contrary religious
9 beliefs or medical judgment.” *Franciscan All., Inc. v. Burwell*, 227 F. Supp. 3d 660, 670 (N.D.
10 Tex. 2016). Those providers, like Amici and many health care professionals, “believe[] that a
11 person’s sex is ascertained biologically, and not by one’s beliefs, desires, or feelings,” and they
12 therefore “do[] not believe transition-related procedures are ever in the best interests of ...
13 patients.” *Id.* Indeed, the Hippocratic obligation “[t]o act only for the benefit of a patient”⁴²
14 precludes its oath takers from mutilating healthy organs, causing sterility, or otherwise assisting
15 in gender transitions, which have been shown to significantly increase suicide, suicide attempts,
and psychiatric hospitalization among patients.⁴³

16 With roughly 20 million people in the U.S. health care workforce,⁴⁴ there are necessarily
17 millions of individuals who share pro-life and biblical views, and do not want to be forced into a
18

1 decision between violating their convictions or keeping their jobs. They may conscientiously
 2 refuse to “participate in or perform the killing of their patients” through euthanasia, abortion, or
 3 assisted suicide.⁴⁵ After all, many nurses, doctors, midwives, and support staff go into health care
 4 because they want to *heal*.

5 California’s complaint that the Rule “greatly expands the breadth of these [existing] laws,
 6 which (at most) address only exemptions to abortion and sterilization procedures,” CA Compl. ¶
 7 66, misses the key point that conscience rights are not limited to particular topics. It is also
 8 incorrect. *See supra* note 11. California’s assertion that its existing state laws “protect employees
 9 from discrimination based on religious beliefs, unless accommodation of those beliefs would
 10 result in undue hardship to the employer,” CA Compl. ¶ 23, misses the point that conscience
 11 rights should not give way to business interests.

12 California also objects that the Rule expands current conscience protections “to include
 13 ‘health care personnel,’ as distinct from a ‘health care professional,’ such as a doctor, nurse or
 14 other licensed medical provider.” CA Compl. ¶ 68. But conscience rights are not limited to
 15 people holding certain job titles. *But see id.* (suggesting with disdain that “even a receptionist”
 16 with “moral objections” might be protected by the Rule). Anyone working in the medical field
 17 may have conscientious objections to facilitating certain acts they believe are morally wrong. An
 18 individual’s moral beliefs are just as sacred regardless of whether they are a considered a
 “professional.”

19 The Rule assures the proper breath of legal protections, so that certain viewpoints or
 20 individuals are not left vulnerable to attacks on their constitutional rights.

21 **V. The Rule provides clear mechanisms for compliance and enforcement that are
 22 lacking in existing law.**

23 The Conscience Rule fills in gaps where other conscience-protecting laws are silent. Its
 24 compliance and enforcement mechanisms are critical to ensuring that conscience rights are
 25 adequately protected, even where other laws purport to do so. While Plaintiffs’ approach would
 26 drive good-faith, skilled health care workers from the profession and enshrine barriers to entry,
 27 the Rule has the opposite effect, keeping doors open for a wider range of individuals who are

1 willing to serve in the field of medicine. The Rule’s “outreach, investigation, compliance,
2 technical assistance, and enforcement practices,” Final Rule at p. 44, provide a multi-faceted
3 legal structure for medical practitioners.

4 The Rule’s specific provisions are appropriate measures to guarantee effectiveness. It
5 contains protections like those in the Civil Rights Act, allowing increased oversight through
6 written assurances, notice to employees, and certificates of compliance. These voluntary
7 compliance mechanisms help to avoid unnecessary disputes and litigation. The Rule also
8 provides for outreach and education to ensure that conscience rights are known, understood, and
9 respected. And the Rule provides for investigations into alleged violations and vigorous
10 enforcement of the laws. These are the teeth that have long been needed to ensure that the crucial
11 bark of conscience laws is no longer ignored.

12 **Conclusion**

13 For these reasons and those submitted by Defendants, this Court should grant Defendants’
14 motion for summary judgment.
