8 Plaintiffs Aiden Stockman, Nicolas Talbott, Tamasyn Reeves, Jaquice Tate,  
9 John Does 1-2, Jane Doe, Equality California and Plaintiff-Intervenor the State of  
10 California (collectively, “Plaintiffs”), and Defendants Mark T. Esper, Joseph F.  
11 Dunford, Jr., Richard V. Spencer, Ryan D. McCarthy, Matthew Donovan, and Kevin  
12 K. McAleenan (collectively, “Defendants,” and, along with Plaintiffs, the “Parties”)  
13 by and through their respective counsel, hereby stipulate as follows:

14 WHEREAS, Plaintiffs filed the above-captioned action on September 5, 2017  
15 (ECF No. 1);

16 WHEREAS, on July 30, 2018, the Court entered the Civil Trial Scheduling  
17 Order (ECF No. 116), establishing a case schedule;

18 WHEREAS, on February 15, 2019, this Court entered the Order on Joint  
19 Stipulation to Modify Case Schedule (ECF No. 144);

20 WHEREAS, on May 23, 2019, the Court entered an order vacating the  
21 amended scheduling order and suspending the remaining deadlines set forth therein  
22 (ECF No. 157);

23 WHEREAS, on June 14, 2019, the Ninth Circuit issued its decision on the  
24 Mandamus Petition in *Trump v. Karnoski*, Case No. 18-72159 (9th Cir.);

25 WHEREAS, on July 12, 2019, the Parties stipulated and jointly proposed an  
26 amended case schedule (ECF No. 161);

27 WHEREAS, on July 15, 2019, the Court entered an order approving the  
28 Parties’ proposed amended schedule (ECF No. 162) (the “Amended Schedule”); and

1 WHEREAS, Plaintiffs have advised Defendants that they intend to designate  
 2 certain expert witnesses on September 16, 2019 as contemplated by the Amended  
 3 Schedule, but proposed that the Parties build in additional time to designate  
 4 additional affirmative expert witnesses.

5 THE PARTIES STIPULATE AND JOINTLY PROPOSE the following  
 6 modifications to the Amended Schedule, limited to the timing of expert witness  
 7 disclosures:
