STIPULATED ORDER EXTENDING DEADLINES

Plaintiff Catholic Charities West Michigan, and Defendants Michigan Department of Health and Human Services (DHHS), DHHS Director Robert Gordon, Michigan Children's Services Agency (CSA), and CSA Executive Director JooYeun Chang¹ (collectively "DHHS Defendants"), and Defendant Michigan Attorney General Dana Nessel, by and through respective counsel, stipulate as follows:

1. Defendants' deadline to respond to the Complaint filed in the above-captioned action is June 28, 2019;

2. Defendants' deadline to respond to Plaintiff's Motion for Preliminary Injunction is June 28, 2019; and

3. To ensure that Plaintiff is not prejudiced by any extension of time, DHHS Defendants will provide Plaintiff at least 10 days' notice prior to taking adverse action, as defined in MCL 722.124e(7), against Plaintiff relating to a Placing Agency Foster Care services contract or an Adoption services contract with DHHS.
