General Comment

I am writing this comment because I am a queer woman with many friends who are also women and/or are queer (part of the LGBT community). I am also an attorney at an organization that does advocacy on behalf of people living with HIV.

I am concerned about this proposed rule because honestly, healthcare access is scary enough as it is right now. My friends and I have to very carefully navigate what clinics we go to, what providers we see because we are worried about putting ourselves in a potentially unsafe situation or in a situation where who we are is going to be under scrutiny. We're always worried about being harassed, scorned, or humiliated just by living our lives day to day and trying to access the same services as every one else. Believe me when I say there are enough healthcare providers already bring their personal biases into the way they provide care, completely ignoring the oath they took to do no harm. They already do not face any consequences for that behavior, which is truly disheartening.

I took an oath too when I became an attorney. I promised to serve the public and to live up to the standards of my profession. Attorneys have to diligently and zealously represent clients that they do not personally agree with all the time. If I failed to do that, if my colleagues failed to do that, then we would lose our jobs, get sued, lose our licenses, etc. Those consequences would be justified. That's the whole point of providing a public service and that includes preventing everyone from injecting their personal moral and religious beliefs into whether someone receives those services.

Please understand, I do not need my healthcare providers to joyously celebrate the fact that I am gay, or that my friends are transgender, or that women are perfectly capable of making family planning decisions for themselves. I just need them to do their job, the job they trained for, are licensed for, and swore to do. If healthcare providers are unwilling or unable to reconcile doing that job with their personal beliefs, that's fine, they can just leave the profession. I think that's a fair ask. I am even fine with my taxes going toward covering their unemployment benefits. If that seems extreme, asking providers to leave the field because of who they are, then know that it seems extreme to me that a doctor could choose not to see me or provide the care I need because of who I am.

This proposed rule to protect the conscience and beliefs of these providers means giving them a blank check to violate their professional ethics in favor of personal prejudices. I believe people should be free to practice their faiths, but that freedom is not unlimited because no rights in the U.S. are unlimited. All rights must necessarily be balanced against all other rights of all other people. Otherwise there no one would have any rights. We all agreed as a society to live within the confines of laws that restrict our freedom to act in certain ways, because that's what it means to be a part of a cohesive whole.

This proposed rule flys in the face of that agreement by infringing on my right to get healthcare services without being mistreated. It makes me and my friends and community less safe by insulating providers who discriminate. I personally, professionally, and morally object to it.

People can disagree over so many aspects of how we live our lives, more than just sexual orientation or gender identity, and none of that should impact a physician's duty to care for people as people. None of this is acceptable, and allowing LGBTQ+ folks to be discriminated against simply because they are queer or trans is morally reprehensible, just as discriminating against anyone is morally reprehensible. If providers feel so strongly that they cannot treat LGBTQ+ people, then they should not be physicians as they are not qualified to first, do no harm. Allowing people to discriminate in providing healthcare will directly lead to the suffering and death of so many people who do not have options in where they receive their healthcare. Research has shown this time and time again. All options should be safe for receiving necessary medical care. Do not let us continue sliding in the wrong direction by promoting lethal discriminatory practices.

I am a lesbian and have been a primary care nurse practitioner in rural Maine for 21 years. Due to my own health problems, I had to give up my clinical practice last year. For many years, I was one of the only primary care providers in the greater Bangor area who had the knowledge and was willing to provide transgender hormone treatment for patients who needed that care. I developed a word of mouth practice where transgender and non-binary patients felt safe and welcomed, and could receive comprehensive primary care that included hormone treatment if they needed that. Prior to finding me, many of my patients had been getting hormones on the street or on the internet, because they could not find providers in the area who would see them and many of them couldn't travel down to Portland, where there were only a few welcoming providers available. Since I left my practice, I have continued to advocate for several of my patients who have now had trouble again finding providers who can give them the care that they need. I, and others in the area have made inroads into educating providers and health organizations in the state about LGBTQ health disparities and particularly transgender health needs, and now there are a few providers stepping up and acquiring the knowledge they need to offer this care. Many are still reluctant--some because of homophobia or transphobia, but others due to lack of knowledge and resources. If health care providers are allowed to legally discriminate and turn patients of any kind away, the slow progress we have made in battling the ongoing health disparities faced by LGBTQ people will only move backwards. I am on Disability now, but when I am able to, I continue to volunteer my time toward educating health care providers, as well as encouraging LGBTQ patients to advocate for themselves in a daunting and confusing health care system. I haven't had an easy career as a lesbian health care provider in a rural part of the country. I have had a lot of push back for my efforts and my views along the way, but taking care of underserved populations was what I set out to do when I became a nurse practitioner. My internal medicine practices over the years have also included a general adult population, but I often attracted a panel slanted toward elderly patients, people with mental health problems, people who use drugs, and the LGBTQ niche, because of my interest in helping the most disenfranchised underdogs in our community. It breaks my heart to see things getting worse now for these people, instead of better. I, myself, have gone from being a fairly comfortable upper middle class professional woman to someone on the verge of bankruptcy, all because of medical issues that led to my not being able to work anymore. This is shameful for the richest country in the world. I am lucky to have the education and knowledge to advocate for myself and the ability to access available resources and support. So many of my former patients do not have this. They rely on a fair and equitable health care system and providers who do not discriminate to help them navigate an often overwhelming bureacracy.

General Comment

When I came out as transgender, I immediately began to feel better about myself. I was happier, healthier, and an all around better person than I had been prior to my coming out. However, other people didn't follow suit - instead of feeling better about me, people around me started to feel worse. This is especially prevalent in the health care experiences I've had. It is common knowledge that the best thing for a transgender person experiencing disruptive dysphoria is transition. However, barriers are vast - multiple health care professionals must agree that you are transgender and advocate for your treatment as such. The perceived legitimacy of my gender identity is not in my hands, as it should be - it rests in the hands of my doctors. It's scary, then, that so many doctors are disgusted, scared, or sometimes even amused by the idea of treating a trans person. I am lucky enough that I am able to choose when to tell someone that I am trans and when not to (this passing privilege is something not all of us have). One example I've experienced was this: I had recently moved to a new city, and I needed a new doctor. I finally got an appointment with a physician, and she was very pleasant. However, towards the end of the appointment, I explained that I am transgender and that this information is vital to many aspects of my health care. She was stunned, and instantly moved herself farther away from me as if being near me would be harmful to her. She stuttered but finally managed to say, "That's not something I do." I asked what she meant and she said that she does not "understand the transgenders" or "know what any sort of health care for them would look like," talking about trans people as if one wasn't right in front of her. I was forced to find another physician - I had to try three more before finally going to a LGBT health clinic with fewer resources and less funding than the practices I had been to before. I have seen this over and over again - therapists, endocrinologists, general practicioners, and even emergency room staff have either struggled with my care or refused to give it. When I was young, I was taken to the emergency room due to an emotional breakdown and suicidal tendencies that my mother didn't know how to handle. After being placed on a suicide watch and waiting two hours (until around 3 AM) for a mental health professional to arrive. I was dismissed with nothing but a simple comment from that person -"This is just because he's gay. I mean, look at him. This is not a real thing." I was later referred to a psychiatrist who misdiagnosed me several times, prescribed heavy drugs that were inappropriate for my age and condition, and argued against my attending college. Nevermind the fact that I've had to go through literal dozens of therapists before finding one that would provide me with treatment. All of these things would not have happened if I had been cisgender. It's possible that my experience with the health care system in America would have been positive or neutral. Keep in mind that I am a white transgender woman. I have struggled, but my struggles are dwarfed by the intense discrimination that transgender people of color experience in the health care system (and in society in general) every single day. It is not acceptable. If the US wants to lead the word, we have to start acting like leaders. Providing more physicians with more ways to legally discriminate against LGBT people will only set the country back. Sure, it might make some voters smile as they laugh at the struggles of people they've never met, will never meet, and will never understand. However, in the long run, you're not helping them - you're hurting us, our children, and future generations of America. This is not about religion - it's about needing health care professionals to do their jobs. We the people of the United States of America beg you to reconsider this idea and take into account the experiences

of LGBT people around the nation - the ones who would actually be affected by your actions. Do with this message what you will, but know one thing - we are not going anywhere, and we will not stand for this.
