As a consequence my mother was forced to exist for another six months and her children were forced to pay for care that she did not want rather than the dignified death which she desired. I firmly believe in freedom of religion and respect others beliefs - I only ask that they respect my beliefs and not force their beliefs on me as they did on my mother!
