STATUS REPORT

On April 22, 2019, this Court *sua sponte* abated these proceedings in light of the Supreme Court’s decision to take certiorari in *Harris Funeral Homes v. EEOC* (18-107), *Bostock v. Clayton Cnty., Ga.* (17-1618), and *Altitude Express, Inc. v. Zarda* (17-1623). As part of that same Order, Dr. Tudor was directed to file a status report on or before October 21, 2019 apprising this Court of the status of the *Harris*, *Bostock*, and *Zarda* proceedings.

On May 1, 2019, Dr. Tudor moved this Court to lift the abeyance arguing that the issues taken on certiorari by the Supreme Court are not dispositive to issues properly before this Court on either direct or cross appeal. *See* Tudor Mot., Doc. 0101016446. On May 15, 2019, this Court summarily denied Dr. Tudor's motion.

To date, the Supreme Court has not taken dispositive action in *Harris*, *Bostock*, or *Zarda*. Additionally, Dr. Tudor reports that the Supreme Court heard consolidated oral arguments in *Zarda* and *Bostock* on October 8, 2019 as well as separate arguments in *Harris* that same day.
