**DEFENDANTS' NOTICE OF INITIAL
AUTOMATIC EXTENSION OF TIME**

Defendants Dr. Virginia Caine, Director and Health Officer for the Marion County Health Department, Darren Klingler, Administrator for Vital Records for the Marion County Health Department, and Charles S. Eberhardt, Dr. James Miner, Gregory S. Fehribach, Lacy M. Johnson, Deborah J. Daniels, Dr. David F. Canal, and Joyce Q. Rogers, all in their official capacities as Trustees for the Health and Hospital Corporation of Marion County (collectively the "Defendants"), hereby provide notice pursuant to Local Rule 6-1(b) of their initial, automatic 28-day extension of time up to and including May 4, 2015, to answer or otherwise respond to the First Amended Complaint for Declaratory and Injunctive Relief ("First Amended Complaint") filed by Plaintiffs. In support, the Defendants state the following:

1. Plaintiffs filed their First Amended Complaint on March 11, 2015, and Defendants were served no earlier than March 16, 2015.
2. Accordingly, Defendants' response is currently due no later than April 6, 2015, which date has not yet passed.
3. No prior extensions of time have been requested by or granted to the Defendants to respond to the First Amended Complaint.
4. The parties have not yet submitted a case management plan and no hearings have been scheduled. Thus, the requested extension will not interfere with a case management plan, scheduled hearings, or other case deadlines.
5. Counsel for Defendants has contacted Plaintiffs' counsel, who has consented to this extension of time.

WHEREFORE, the Defendants respectfully notify the Court and counsel of their initial 28-day extension of time, up to and including May 4, 2015, to answer or otherwise respond to the Complaint.
