**STATUS REPORT**

On April 22, 2019, this Court *sua sponte* abated these proceedings in light of the Supreme Court’s decision to take certiorari in *Harris Funeral Homes v. EEOC* (18-107), *Bostock v. Clayton Cnty., Ga.* (17-1618), and *Altitude Express, Inc. v. Zarda* (17-1623). On January 3, 2020, Dr. Tudor was directed to file a status report on or before February 3, 2020, and every 45 days thereafter, apprising this court of the status of the *Harris*, *Bostock*, and *Zarda* proceedings. A status report was due on March 17, 2020. Plaintiff is filing this report late due to office disruptions occurring because of the COVID-19 pandemic. Plaintiff respectfully requests this report be accepted *nunc pro tunc*. The next report will be due on May 1, 2020.

On January 15, 2020, the undersigned counsel, Jillian T. Weiss and Jerry L. Colclazier, entered appearances on behalf of Dr. Tudor, and moved for substitution of counsel, including withdrawal of prior counsel Ezra I. Young and Brittany Novotny. The motion was fully submitted on January 16, 2020. No action has yet been taken on the motion for substitution.

The Supreme Court heard consolidated oral arguments in *Zarda* and *Bostock* on October 8, 2019 as well as separate arguments in *Harris* that same day. A review of the Supreme Court docket reveals that it has not taken dispositive action in *Harris*, *Bostock*, or *Zarda*
