2 the 350-document set thus far, which Defendants will produce to the Court today *in camera*.
3 However, additional rounds of document selection and review are necessary to complete the
4 350-document set ordered by the Court. Accordingly, Defendants, without opposition, request
5 a one-week extension to June 5, 2020 of the deadline to identify sample documents and provide
6 them to the Court.
