**DEFENDANTS' NOTICE OF
COMPLIANCE WITH ECF NO. 532**

1 Pursuant to the Court’s Minute Order Directing Defendants to File an Updated Privilege
2 Log for the Court’s *In Camera* Review Re: Dkt. Nos. 525, 530, ECF No. 532, Defendants hereby
3 provide notice and a description of their compliance.

4 The Court ordered the Government to “consolidate its separate privilege logs into a single
5 document and to include two separate columns indicating the beginning PrivWithhold page
6 number and the ending PrivWithholding page number for each document.” Order at 1, ECF No.
7 332. As reflected in the attached privilege log, the Government has consolidated the two
8 privilege logs that were submitted to the Court on May 29, 2020 and June 5, 2020, and the
9 Government has added two separate columns indicating the beginning PrivWithhold page
10 number and the ending PrivWithholding page number for each document. The Government
11 sorted the log by the beginning PrivWithhold page. The Government has also separately
12 submitted the attached privilege log in Excel format to the Court.

13 In creating this consolidated privilege log, undersigned counsel discovered two
14 inadvertent errors in the logs submitted to the Court that were correct in the consolidated privilege
15 log that Defendants submitted to Plaintiffs. Defense counsel has corrected those errors in the
16 attached log to match the information on the consolidated privilege log provided to Plaintiffs.

17 First, privilege log information (*i.e.*, date, author, recipient, title, privilege, and privilege
18 description) was inadvertently omitted for three entries (Document IDs DoD00085466,
19 DoD00085543, DoD00004716) on the logs that were previously submitted to the Court. This
20 information was included on the consolidated privilege log that Defendants provided to Plaintiffs.
21 Defendants have copied the information from the consolidated privilege log that Defendants
22 provided to Plaintiffs for these three entries and included that information in the attached
23 privilege log.

24 Second, the Privilege column for two entries (Document IDs Army_10009001.0002,
25 Army_10009002.0001.0003) listed the privilege as “DP – Deliberative; Not Privileged.” The
26 Privilege column for these two entries in the consolidated log that Defendants submitted to
27 Plaintiffs stated only “DP – Deliberative.” The “Not Privileged” entries on the logs submitted to
