Steve and Rena: You might have already spoken to Mat, but in case you didn't, I'll share my notes with you regarding the Bedford county J&DR court hearing today.

Bonnie: Please save this email as attorney notes to the file.

First of all, I sense that Rebecca Glenburg was surprised that Rena was not there with Mat. She kept looking at me with a puzzled look on her face, like "who is that sitting with Mat at the counsel table and where is Rena?" That in itself was worth the price of admission.

However, it got better.

Mat started off with questioning whether the court could proceed with the show cause portion of the hearing because Lisa had not

been served. The judge said that he could not proceed on an OSC without proof that Lisa had been served. Rebecca brought up the fact that LC had filed an appeal of the court's order registering the VT order and had listed Lisa's address in care of LC. However, the judge pointed out that while service on counsel might be appropriate in an existing civil matter it would not work to establish service in a criminal OSC. Rebecca tried to argue that Lisa should not be able to avoid the court proceedings by deliberately evading service. However, the court asked her for legal authority showing that he could exercise in personam jurisdiction over Lisa without service, and Rebecca could not offer any.

Rebecca asked for a capias to issue but the court declined due to not being able to locate Lisa.

Rebecca then asked for a warrant ordering immediately transferring custody to Janet. The court said that Janet already has custody per the VT order. Rebecca asked for an order for physical custody, and again the court said that exists in the VT order. She asked for an order permitting law enforcement assistance to find Isabella. The judge said there is an order in place permitting law enforcement assistance in finding Lisa, and in finding Lisa they would find Isabella. Nonetheless, she asked for a separate order permitting law enforce to help locate Isabella, and the court agreed after Mat said he did not have any objection, albeit it would duplicative of what exists.

The judge then said that Rebecca would be permitted to call witnesses on the issue of trying to locate Lisa and Isabella.

Rebecca sought to call Janet, who was on the phone. Mat questioned whether there was anyone present with Janet who could attest to her identity and swear her in. Rebecca said no, that she had been told by the clerk's office that the clerk would do that on this end. Mat objected and the court agreed that she could only testify if she could get a notary on her end to attest to her identity. Then he asked why Janet needed to testify. Rebecca said she needed to testify about the fact that Lisa did not comply

with the order to transfer custody. The court said that was pretty much a given and Mat agreed that we would stipulate that the transfer did not take place. With that, the court did not see any need to call lanet.

Rebecca called Todd Campo, the superintendent for LCA. She asked him whether Isabella was a student, for how long and whether he had any records of her transcripts being transferred or knowledge of whether she was in school or where. He did not. She then asked about Lisa's employment and why she did not return. He testified that her contract was not renewed. She then tried to start questioning him regarding why it was not renewed, but Mat and the attorney for LCA objected on relevance grounds. The objection was sustained and she withdrew the question. She then asked him if he knew where Lisa is or whether she had asked for references to be sent to another employer. He said no to both.

The guardian ad litem for Isabella asked a few questions about Isabella's attendance record, and Campo could only offer generalizations.

Rebecca then called Debbie Thurman. She responded to questions about when she met Lisa (October 2008) and her role with the "Only One Mommy" Facebook page (co-administrator). Rebecca then showed Debbie a printout of the December 4th posting of a note from Lisa and asked about it. Debbie said that she posted the note, but did not receive it from Lisa directly. She said that Sylvia Haydash emailed the note to her. She had not heard from Sylvia before. She said she contacted Sylvia shortly after that to touch base, but did not have any information on where Sylvia got the note. Rebecca asked her about the status of the Facebook page. Debbie said that it had been taken down because she and the other co-administrator found it to be too overwhelming to keep up. Rebecca asked who the coadminstrator was and Debbie said Rena. Rebecca then tried to elicit from Debbie that the timing of the site being taken down coincided with the date of the custody hearing in August 09, but Debbie could not remember the precise date and said that it was

not related to that hearing. Rebecca then asked Debbie when she last saw Lisa (at church in early September) and her last communication (an email dated 9/19 sent from Lisa's aol address). She that Lisa was visiting her brother at the time and when asked where the brother lived said that she believed Winchester. She responded that she did not know where Lisa was or anyone who might know. She said that Lisa did not talk about moving, leaving Va. Or going into hiding (DUH. Stupid question).

Rebecca called Linda Wall, but Linda did not respond to the bailiff's page. Apparently, there were issues regarding service on Linda, but Rebecca said that she thought that Linda would be there anyway.

That ended the hearing. The court set a further hearing for May 19th at 2:30 with an understanding that if Lisa is found it will be moved up. If she is not, he suggested that it might be done via phone.

All in all, a good day. The ACLU left empty handed – always a good thing.

#### Virginia Is Ground Zero in Landmark Parental Rights Case

LYNCHBURG, Va. -- A groundbreaking, years-long case that gay rights activists are banking on to set a legal precedent in child custody disputes between homosexual partners formerly joined in civil unions is moving toward its conclusion in a hearing set for Oct. 27.

Hanging in the balance is the future of a six-year-old girl living with her biological mother here. The child could be forced to live far away from the only home she knows with an unrelated woman deemed her second "mother" by a Vermont court.

Lisa Miller, a Virginia resident, is the actual mother of Isabella, a child she conceived through artificial insemination via an anonymous donor in the Commonwealth while in a brief, Vermont-sanctioned civil union with a lesbian partner who now resides in Vermont, Janet Jenkins. Unhappy in that relationship and choosing to forgo the lesbian lifestyle, Miller relocated to Central Virginia with her then-17-month-old daughter to start a new life, and filed in Vermont to dissolve the union.

A court in Vermont granted visitation rights to Jenkins as Isabella's other "mother," despite the fact that Jenkins had never legally adopted the child and no law existed in Vermont to cover such a contingency. Miller allowed Jenkins one or two unsupervised visits with Isabella, but became concerned for her child's welfare because of Jenkins' openly lesbian lifestyle and troubling reports she received from Isabella, who by that time was 5.

Miller refused to allow further visits, and was held in contempt by the Vermont court, which has the authority to award full custody of Isabella to Jenkins, whom she barely knows. In fact, until recently, Jenkins had openly sought full custody.

"Janet Jenkins is a legal and an actual stranger to Isabella. The idea that a court can unilaterally change the law and defy logic to declare Janet a second mother to Isabella is absolutely shocking. It's a raw abuse of judicial authority," said Rena Lindevaldsen, an attorney for Lisa Miller.

In June, the Virginia Supreme Court heard an appeal from Miller's legal team to overturn a 2004 Virginia Appeals Court decision that directed a Virginia circuit court to register the previous custody and visitation order from the Vermont court, even though the circuit court had previously awarded sole parental custody of Isabella to Miller. The Virginia Court of Appeals held that the federal Parental Kidnapping Prevention Act (PKPA) required the courts of the Commonwealth of Virginia to give "full faith and credit" to the Vermont order.

Miller's attorneys have argued, to no avail, that the Defense of Marriage Act (DOMA), the Marriage Affirmation Act and the Virginia Constitution's Marriage Amendment take precedence over PKPA. Virginia Supreme Court Chief Justice Leroy R. Hassell Sr. has even stated that the Virginia Court of Appeals erred in its ruling.

Various church and community supporters are planning to gather for a special prayer service for Lisa and Isabella Miller at the Liberty University Law School on Sunday, Oct. 19, from 4-5 p.m. Friends have organized a Facebook group called "Only One Mommy: The Story of Lisa and Isabella Miller."

Lisa and her legal team will be in a Vermont family court on Oct. 27 for a hearing to determine custody of Isabella. If the court decides in favor of removing Isabella from her biological mother and awarding sole custody to Janet Jenkins -- an unrelated essential stranger to the child -- it will be first time such a decision is handed down by any court in the United States




