## Subjectr Data Compiled on Lesbian Couples DV Rates; Higher Than Any Other Couple

People who endured a lot of hurt and neglect in their lives, especially during their childhood and adolescentteen years from the people who were the most important in their lives at the time (mom, dad, siblings, close friends, etc) are more likely to develop hardened hearts.

As a defense mechanism, they become emotionally detached, but are often on the hunt for their mirror selves.
They often seek the one who will draw them in with romantic intensity and then distance themselves when things get too close. A romanticized/sexualized relationship between two women is much more prone to excessive intensity, lack of privacy, a strong tendency for psychological fusion with a followed loss of the sense of one's separate feelings, and an inability to express or tolerate differences. (Enmeshment._loss of boundaries). The requirement of sensitive mutual understanding will inhibit healthy aggression, and a trend toward a suffocating exclusivity.

Because the identification is defined by their attractions as the foundation of their character and personality, they subconsciously perceive relationships as if they are sole answer to absolute happiness and utopia, and can't seem to connect the dots when it comes to the unbalanced nature of these homosexual relationships. As they crave and desire their relationships to be the answer to their happiness, they often struggle just to keep the relationship hanging on a thread. There is this constant struggle to supplant the role of the male into their lesbian relationships, which is impossible, and that's why the relationship either implodes so much andlor so quickly, or they become reduced to something that is really just the same as two roommates living together using each other as masturbatory aides, and then calling that "love."

Although reported incidences of intimate partner violence, or IPV, are widespread, especially among women and certain ethnic groups, reported IPV is highest among lesbians, and second highest among homosexual male couples in California (one of the most pro-homosexual friendly states), and who are almost twice as likely to experience violence than heterosexual adults, researchers said.

And there are even more studies that were conducted that back this up:

- Among lesbians, a 1985 study by Gwat-Yong Lie and Sabrina Gentlewarrier reported that slightly more than half of 1,109 respondents had been abused by a woman partner in their lifetime. (Gwat-Yong Lie \& S. Gentlewarrier. Intimate Violence in Lesbian Relationships: Discussion of Survey Findings and Practice Implications, p. 46 (1991) 15 Journal of Social Service Research The Haworth Press)
- Coleman's 1990 study of 90 lesbians, for example, reported that $46.6 \%$ had experienced repeated acts of violence. (Coleman, V. The Relationship Between Personality and the Perpetration of Violence, Internet, Abstracted from Violence and Victims, Vol. 9, No. 2, 1994)
- Ristock's 1994 survey of 113 lesbians reported that $41 \%$ been abused in at least one relationship with another woman. (Ristock, J., And Justice for All?...The Social Context of Legal Responses to Abuse in Lesbian Relationships, (1994) 7 Canadian Journal of Women and the Law 420)
- In another one of Ristock studies of domestic abuse in in 2002, lesbian relationships, Ristock (2002) identifies first same sex relationships as high risk for domestic abuse. We would agree that first same sex relationships present a particular set of circumstances in which abuse may occur: the survivor's investment in wanting a same sex relationship as confirmation of their identity, sense of self, and the safer alternative to men if they have had bad relationships or experiences with men more than not; their lack of confidence in what behaviors are acceptable in intimate relationships; and their possible lack of embededness in LGBT friendship/community networks in which to air their concerns, see other relationship role models, and seek support and help in addressing the abuse they are experiencing.

For example, Audrey when she had her first lesbian relationship, which lasted for nearly 3 years. This was an abusive relationship, but she says it took her longer to understand it as such, because she was so exhilarated by her experience of it as her first lesbian relationship:
"Well, I think I'd always been very clear about what was going on, but suddenly I realized actually I was beginning to abuse myself by staying in this relationship and if that - and I knew, I just knew that if that had been a man, with a man because my worst relationship (so far) was with a man. I would not have put up with three years of that actually. I would not. So why was it any different? Because this was a relationship with a woman and it was my first, I didn't want to believe it."
(Ristock, J. (2002) No More Secrets. Violence in lesbian relationships. Routledge: London.)

A study in the Journal of Interpersonal Violence examined conflict and violence in lesbian relationships...
The researchers found that $90 \%$ of the women in lesbian relationships surveyed had been recipients of one or more acts of aggression from their intimate partners during the year prior to this study, with $31 \%$ reporting one or more incidents of physical abuse. (Lettie L. Lockhart et al., "Letting out the Secret:Violence in Lesbian Relationships," pp. 469-492 Journal of Interpersonal Violence 9 (1994))

Another study of lesbian couples reported (2000) in the Handbook of Family Development and Intervention "indicates that 54 percent had experienced 10 or more abusive incidents, 74 percent had experienced six or more incidents, 60 percent reported a pattern to the abuse, and 71 percent said it grew worse over time." (William C. Nichols, et al, editors, Handbook of Family Development and Intervention, p. 393 (New York: John Wiley and Sons, Inc., 2000))

Studies of other populations in the LGBT "community" have documented even higher rates of abuse over respondents' lifetimes:

- The Portland, OR based Survivor Project's 1998 Gender, Violence, and Resource Access Survey of transgender and inter sex individuals found that $50 \%$ of respondents had been raped or assaulted by a romantic partner, even though only $\mathbf{6 2 \%}$ of these individuals identified themselves as "survivors" of domestic violence when asked. (Courvant, Diana and Loree Cook-Daniels, 'Trans and Intersex Survivors of Domestic Violence: Defining Terms, Barriers, \& Responsibilities,' www.survivorproject.org/defbarresp.html .)
- Another survey found that same-sex cohabitants reported significantly more intimate partner violence than did oppositesex cohabitants. Among women, $39.2 \%$ of the same-sex cohabitants and $21.7 \%$ of the opposite-sex cohabitants reported being raped, physically assaulted, and/or stalked by a marital/cohabiting partner at some time in their lifetime. - Another study indicated that $83 \%$ of homosexuals report they have been emotionally abused by homosexual partners. (A

Descriptive Analysis of Same-Sex Relationship Violence for a Diverse Sample, The Journal of Family Violence, Publisher Springer Netherlands, Volume 15, Number 3, September, 2000, Pages 281-293. ISSN 0885-7482)

- 88\% of victims in 2003 and 91 percent of victims in 2004 reported experiencing prior incidents of abuse, with the majority ( 45 percent and 47 percent, respectively) reporting having experienced more than 10 prior incidents. (Diane Dolan-Soto \& Sara Kaplan, New York Lesbian, Gay, Transgender and Bisexual Domestic Violence Report, at 5 (2005), available at http://www.avp.org/publications/reports/2005nycdvrpt.pdf.)

## WE CAN NOT OBEY AN UNJUST LAW!

Dear Friend,
The words above are the solemn message that I, along with other national leaders, declared as the U.S. Supreme Court heard arguments on marriage.

In light of the absurd notion that "marriage is on trial", I co-drafted a Marriage Pledge and now a broad cross-section of national religious and political leaders representing Evangelicals, Catholics, Orthodox Christians, and Jewish communities have come together to stand in unity. "We Stand in Solidarity to Defend Marriage" they declared.

The Marriage Pledge states that "marriage is so fundamental to the natural order and the common good that this is a line we must draw and one we cannot and will not cross." God designed marriage with one-man and one-woman and Jesus affirmed marriage in Mt. 19:4,5.

An assault on marriage is a direct assault on our Creator and His creation. Like saying a Da Vinci painting is a mistake and painting over it - this assault is as if the created being declares that the Creator made a mistake and the created being knows better than the Creator.

Though we hold the highest respect for the rule of law - we also can not and will not respect an unjust law that directly conflicts with higher law. We pledged to do whatever it takes to defend natural marriage from a massive radical homosexual and legal onslaught.

Never have the stakes been higher. My colleague Dr. James Dobson and I agree that same-sex marriage will fracture the nation. If you weaken or undermine natural marriage - our entire civilization is threatened.

We have a Biblical basis for opposing any law or ruling that is against God's laws. Daniel and the three Hebrews did not bow to the King's edict. Moses' parents disobeyed Pharaoh to obey God. Esther disobeyed the Persian law and approached the King, even though he had not summoned the Queen. The Apostles were told to not preach in the name of Jesus - but they obeyed God rather than man. And our Founding Fathers stood against the unjust laws of the King of England to forge this nation. Benjamin Franklin is reported to have said of the battle to ensue, "We must indeed all hang together or, most assuredly, we shall all hang separately."

I am writing to ask if you will stand with us in defending marriage. I believe that if we do stand together - we can have great impact in this battle. We will fight this battle in the court of public opinion... in the legislatures and Congress... in the courts... and with peaceful resistance if necessary.

I have enclosed the Marriage Pledge and I ask you to read it, and then return the reply card to me stating that you have signed on with me. And I am asking if you will pray for the Supreme Court decision ... and support our efforts.

If this government and Supreme Court attempts to put people of faith "in the back of the bus" simply
for our religious beliefs - we will NOT voluntarily walk to the back of the bus! I hope that you feel the same way and will stand with me!

The radical agenda to destroy marriage and trample religious freedom is not some distant future possibility. It is here now and we must stand. We have no other choice.

Christians and people of faith have been demonized and dehumanized. The radical agenda has no respect for human dignity. If you will not promote a sexually immoral union then you are targeted for insults, and punished like the baker who was fined $\$ 135,000$ for refusing to bake a cake for a same-sex ceremony.

If the Supreme Court ruling (expected in June), sides with same-sex marriage, such a ruling will trigger a domino affect that will significantly impact people of faith, faith-based businesses; faith-based organizations, including churches, pastors, religious education institutions, adoption ministries, and more.

The president's own lawyer admitted before the Supreme Court that if the Court sides with same-sex marriage, churches may lose their tax-exempt status. "That will be an issue," the Obama attorney said. Radical homosexual groups are already calling for that to happen.

Attacks against people of faith have been increasing as bakers, florists, photographers and others have been viciously attacked, physically threatened, or have had outrageous penalties and fines brought against them by government officials and judges - simply for not bowing to homosexual demands, expressing opinions that don't support homosexuality and standing up for their religious beliefs.

Last year we helped support the group of Houston pastors who were threatened with subpoena by the radical lesbian mayor for simply speaking out against her pro-homosexual transgender ordinance. Another pastor in Massachusetts has been sued by a radical homosexual group simply for speaking out against homosexuality.

We both know that the persecution of Christians in America will only get worse if the Supreme Court is so off base as to side with same-sex marriage. Pastors, leaders, politicians and citizens like you and me will face persecution if we dare to speak out in favor of natural marriage.

The Supreme Court has made disastrously wrong decisions before as in the Dred Scott case ruling that blacks are not citizens and another ruling that led to the "eugenics" movement which was eventually cited by the Nazis as a model for Hitler's genocide. A ruling in favor of so-called same-sex marriage will utterly and completely transform the face of society and will result in the beginning of the end of Western Civilization!

In reality, marriage is not on trial any more than gravity is on trial. Marriage is what marriage is - the union of a man and a woman. What is on trial is the judiciary. If the courts and judges are so blind as to not recognize marriage and so arrogant to think they have the authority to change it, then such rulings deserve no respect. They do not represent the rule of law because they are contrary to the Natural Law.

Marriage predates civil government. It is objectively the union of a man and a woman. It is the foundation of our entire culture, and it must be defended. It is only within the last 11 years or so that this sacred institution has come under attack from activist judges and radical homosexuals.

Same-sex marriage as a policy matter says boys and girls don't need moms and dads - that they are irrelevant. Gender becomes pointless when government adopts same-sex marriage. It says that two moms or two dads is equivalent to a mom and a dad.

Same-sex marriage is the most divisive and culturally destructive issue to face America since the Supreme Court's abortion decision in its 1973 Roe v. Wade decision legalizing abortion. But the difference now is that as horrific as Roe v . Wade has been, that Supreme Court decision did not force people to participate in abortion - but a decision legalizing same-sex marriage will force citizens to accept it.

And if the line of same-sex marriage is crossed - then the door is opened for polygamy, polyandry and who knows what. Deviants are already pushing for relationships with children.

So if the Court sides with same-sex marriage we cannot recognize the legitimacy of their ruling because it will not be grounded in the Rule of Law. In a peaceful way, we must resist it in every possible way as much as Dr. Martin Luther King resisted unjust laws in his time. Christians and people of faith may well be forced to engage in peaceful acts of civil disobedience to unjust laws and unjust rulings.

That's why I, along with a number of prominent religious leaders, have told the Supreme Court that redefining marriage is a red line that cannot be crossed. We warned them that if they do cross that line, WE CAN NOT AND WILL NOT CROSS THAT LINE. We have no choice. We cannot compromise our religious convictions. If pushed, we must take a stand.

And we will be considering pressuring Congress to utilize the Constitution's only remedy for unelected, unaccountable, runaway federal judges who go the wrong way with unjust rulings - which is impeachment and removal from their position.

## Alabama High Court Takes On Out-Of-State Parental Rights Battle

The Alabama Supreme Court will hear an appeal involving a child caught between two former same-sex partners split between California and Alabama. Liberty Counsel filed the appeal in the case of $N B V A K$, asking the Alabama Supreme Court to take the case. The Alabama Court of Appeals ruled that the state must recognize and enforce a California decision, declaring that a former same-sex partner with no biological or adoptive relationship has parental rights.

The woman represented by Liberty Counsel (who is known as "N.B." in the case) is the biological mother of a nine-year-old girl. At the time of her daughter's birth, she was in a same-sex relationship in California. Well after the relationship ended, the former partner ("A.K.") sued, and a California court declared A.K. a "de facto" parent, granting her visitation rights.

Briefs will be filed with the Court in the next few weeks. Pray for a favorable outcome and that "N.B." will be able to continue to raise her own child without interference from the unrelated woman.

The Southern Poverty Law Center's legal attack on Liberty Counsel has become unreasonable. Because of the SPLC's extreme "discovery" demands, including materials that are already readily available in court records, our staff attorneys were forced to produce 13,000 pages of legal documents which we delivered last Friday.

That costly, time-consuming and pointless witch-hunt took 200 hours of our precious attorney time.

Speaking to a friendly crowd, the SPLC's Mark Potok unveiled the radical Southern Poverty Law Center's hidden agenda.
"Sometimes the press will describe us as monitoring hate crimes and so on," said Potok, who at the time served as an SPLC spokesman and editor.

But the SPLC is much more than just a so-called watchdog on hate, insisted Potok in remarks caught on video.

I was dismissed from the case, but Liberty Counsel was not. That wasn't enough for the SPLC. So, in 2018, they filed yet another lawsuit, naming both me and Liberty Counsel - this time in Virginia. They wanted to take this ministry down while also destroying my reputation as an attorney.

Of course, our legal team fought back in both states. And last year, a federal
judge in Virginia tossed out the SPLC's Virginia lawsuit. But the one in Vermont is ongoing. And it is extremely costly and time-consuming.

But the SPLC alleges we must have been part of helping her escape the jurisdiction of the courts. Of course, this is a lie.

This attack is part of a broader agenda by the SPLC and other radical groups seeking to destroy their opposition through lies and intimidation.

# The "Freedom of Choice Act" Isn't Free and Offers No Choice 

A people without understanding will come to ruin. - Hosea 4:14

When Barack Obama became President on January 20, he made history. His election has conclusively proven that anyone from any background can succeed in America. Further, pregnant women who are confused about their options will be denied the information they need to make informed decisions, and counsel for life-affirming decisions will be severely restricted. So much for choice.

Whether you're talking about parental notification laws, restrictions on late-term abortions such as the gruesome "partial-birth" procedure, laws requiring waiting periods, informed consent, sonograms, regulations prohibiting our tax dollars from funding abortions, conscience clauses for pharmacists and medical personnel, or laws allowing doctors to refuse to perform abortions - under President Obama's plan, they will all be history.

Under FOCA, pro-life pregnancy centers that provide information on abortion alternatives and adoption will be regulated out of existence.

States will be unable to print "Choose Life" license plates that have helped fund such centers. Pro-life sidewalk counselors will no longer receive police protection from harassment by abortion clinic workers or radical anti-life activists.

Even human cloning will likely be allowed, because FOCA forbids the government from stopping a woman from choosing to bear a child. If the only way she can have a child is by using cloned embryos - that will be

# Will Traditional Marriage Go Up In Smoke? NOT ON MY WATCH! 

The new Pelosi/Reid/Obama axis of political power bas placed the federal Defense of Marriage Act (DOMA) in the crossbairs of its "first 100 days" agenda. If they succeed in repealing DOMA, marriage as we know it will be destroyed.

In January we were in court in both Virginia and Vermont regarding a Vermont order arising from a same-sex civil union law that has recognized Janet Jenkins as a parent to Lisa's own biological child.

The Vermont court order also requires visitation. I can't begin to tell you the emotional consequences that have already impacted Lisa and Isabella, after the Vermont court forced Lisa to allow Isabella to visit Janet. On a recent visit, we learned that Janet read the radical homosexual book entitled "Heather Has Two Mommies" to Isabella.

Little Isabella, who is a bubbly, blonde-haired Christian child, has suffered intense emotional consequences. She began to wet her bed, experience nightmares, and suffer the

Sarah,
First, let me thank you for your efforts to try to work things out. I appreciate it very much. Second, as to the make-up day and efforts to reach a compromise, if we cannot come to an agreement we will file a motion and formal objection to the proposed order: It is simply unacceptable, in my opinion, for Isabella to be forced to miss a school day in order to comply with the visitation order, and I do not believe Judge Cohen intended such a consequence. Further, the offer from Janet was to get anot her
three days in exchange for one day missed, which Lisa was not willing to give. So I guess it goes both ways here, too.

For what it is worth, I think our motion would seek a modification of the March visitation terms from the 9:00 a.m. drop off time to 1:00 p.m., and from the 5:00 p.m. drop off time to 1:00 p.m.; and a modification of the May visitation terms from a 5:00 p.m. pick up time to 3:00.

As for the bridal shower, thank you for the invitation, but as I understand it, Isabella did not ask to be allowed to attend, but only whether Janet intended to take her there; she does not want to go under these circumstances.

Moreover, regarding the communications between the parties, let me state for the record that while it is understandable that you would believe your client over Lisa, I resent and unequivocally deny that Lisa is "misrepresenting things that Janet has said to her." I think it is absurd to suggest that Lisa simply made up the idea that they had reached an agreement, and that it is far more likely that Janet actually did agree when speaking with Lisa, and only after reflecting on the matter reconsidered and withdrew her agreement. Whatever was actually said, I agree with you that until trust is built on both sides, the telephonic communications will remain a problem. Nevertheless, they should (and must, under the court order) continue.

Regarding video conferencing: Lisa is agreeable, and would like to insure that before she purchases expensive equipment, Janet is on the record as agreeing to acquire the technology on her end necessary to make it happen.

I guess I am not clear as to what specifically you would like from Lisa regarding the two visiting days. Are you just wanting dates?

P.S. We also resent your suggestion that the only way Lisa will comply is if the order is registered for enforcement in Virginia.

I am afraid that we are moving backwards with respect to our negotiations. Janet will not (and should not) give up more parent child contact in exchange for one make-up day. Moreover, she does not feel that transportation convenience can be exchanged for quality time with her daughter. She was willing to rearrange things for one day so that Isabella did not need to miss school, but given how much contact has already been missed, she feels that the quality time is more important than one missed school day. Hence, I think it is best to just stay with the order as stated.

Isabella is still welcome to attend the bridal shower if Lisa will allow it. She did express a desire to attend, and I am sure that the Jenkins' could arrange transportation.

Janet vehemently denies that she reached any sort of alternative agreement with Lisa regarding visitation for March. She did say that she would consider it, and she did. If you all recall, this is the same claim that Lisa made regarding Thanksgiving - that after court, Janet agreed to less time than she was entitled to. If communication is to be encouraged, it does not help things for Lisa to (now twice) misrepresent things that Janet has said to her. Communication will continue to be an ongoing problem if the trust problem continues. This is why I suggest starting communication again through email, and eventually trust can be rebuilt and communication can flow more easily. That being said, I did instruct Janet to return Lisa's call, and she informed that she did and left a message. I am not sure if the two have actually spoken yet.

As for the visiting days in the summer, I have not received a response or counter-proposal. I have also not heard anything back about the video-conference capabilities that Lisa has. Janet is not going to invest in a camera adapter until she knows that Lisa is willing to as well, because it won't work if both people don't have the right equipment.

If I don't hear anything back regarding the above matters by the end of the week, I am going to go ahead and submit the proposed order without any summer visit days or make up days included. I need to get the order going so we can get it registered in Virginia in a timely manner, especially because Lisa is pretty clear that she will not abide by an order unless is it capable of being immediately enforced in Virginia. Hence, while it would be great to work out the best possible schedule, the overriding importance of registering the order takes precedence for me.

After five years of litigation, I wonder how much can actually be agreed upon between the parties with regard to make up time etc. I have been willing to try, but please be aware that I am a busy solo practitioner, and do not have unlimited time to negotiate make up time and alternative visitations. Hence, at this time, I am very inclined to simply advise Janet, that until there is a level of trust built up between she and Lisa again such that they can negotiate/communicate between themselves in the best interests of Isabella, that the order simply needs to be followed verbatim. I strongly believe that the only way this trust is going to be rebuilt is for Lisa to show, at the very least, that she can and will comply with the court order.

If you would like to discuss further, perhaps the three of us can arrange a phone conference.

As Christian lawyers, we work within the law and the courts to advance religious liberties and use the law as a fulcrum for the advancement of the Kingdomof God. When the task before us does not provide an opportunity to do either, we are not shirking any responsibility to decline the representation. Sometimes the law is firmly set in a jurisdiction and taking the case will not afford an opportunity to change it (thus potentially wasting limited resources that could be used in a more fruitful endeavor). In those cases, litigating to an unsuccessful end (for the principle) can actually have the effect of adding to the unfavorable reported precedents, making it more difficult to get a positive result elsewhere. We would prefer to fight the battles in other jurisdictions where the law is not yet set, in hopes of getting reported opinions that conflict with the jurisdictions where the law is firmly set, setting up a battle for final interpretation by the Supreme Court.

There are three God-ordained institutions: The Church, The Government and The Family. When government leaders establish laws that steer individuals away from obedience to God, they bear responsibility for the result. So, she must do what she is called to do and suffer whatever the costs of obedience are. Paul, Peter and John did and they spoke to the tribunals without aid of counsel. I think I recall that Paul and Peter were executed (or at least died in prison) for their witnessing. While I do not believe that would happen in the United States, God may have a big test or trial of faith in front of . That is a separate matter from whether Liberty Counsel must (or should) provide her legal representation through that test and trial.

We do advocate for Christians who take actions that are against the lawwhen the law provides a means for success (i.e. the law is unconstitutional as an impermissible burden on the free exercise of religion). When the law will not provide any aid or cannot provide any aid, I cannot see the reason for undertaking the legal representation. They can lose without our help and without utilizing the finite resources of Liberty Counsel.

This response is more of a philosophical one with my extemporaneous thoughts at the close of a long day, not for distribution to Ms. or outside Liberty Counsel. Others undoubtedly see it differently. Nevertheless, I thought the issue merited some thoughtful reply. Especially since I was the attorney who had the last conversation with Ms. $\square$

## Preamble

Christians are heirs of a 2,000-year tradition of proclaiming God's word, seeking justice in our societies, resisting tyranny, and reaching out with compassion to the poor, oppressed and suffering.

While fully acknowledging the imperfections and shortcomings of Christian institutions and communities in all ages, we claim the heritage of those Christians who defended innocent life by rescuing discarded babies from trash heaps in Roman cities and publicly denouncing the Empire's sanctioning of infanticide. We remember with reverence those believers who sacrificed their lives by remaining in Roman cities to tend the sick and dying during the plagues, and who died bravely in the coliseums rather than deny their Lord.

After the barbarian tribes overran Europe, Christian monasteries preserved not only the Bible but also the literature and art of Western culture. It was Christians who combated the evil of slavery: Papal edicts in the 16th and 17th centuries decried the practice of slavery and first excommunicated anyone involved in the slave trade; evangelical

Christians in England, led by John Wesley and William Wilberforce, put an end to the slave trade in that country. Christians under Wilberforce's leadership also formed hundreds of societies for helping the poor, the imprisoned, and child laborers chained to machines.

In Europe, Christians challenged the divine claims of kings and successfully fought to establish the rule of law and balance of governmental powers, which made modern democracy possible. And in America, Christian women stood at the vanguard of the suffrage movement. The great civil rights crusades of the 1950s and 60s were led by Christians claiming the Scriptures and asserting the glory of the image of God in every human being regardless of race, religion, age or class.

This same devotion to human dignity has led Christians in recent decades to work to end the dehumanizing scourge of human trafficking and sexual slavery, bring compassionate care to AIDS sufferers in Africa, and assist in a myriad of other human rights causes - from providing clean water in developing nations to providing homes for tens of thousands of children orphaned by war, disease and gender discrimination.

Like those who have gone before us in the faith, Christians today are called to proclaim the Gospel of costly grace, to protect the intrinsic dignity of the human person and to stand for the common good. In being true to its own calling, the call to discipleship, the church through service to others can make a profound contribution to the public good.

## Declaration

We, as Orthodox, Catholic, and Evangelical Christians, have gathered, beginning in New York on September 28, 2009, to make the following declaration, which we sign as individuals, not on behalf of our organizations, but speaking to and from our communities. We act together in obedience to the one true God, the triune God of holiness and love, who has laid total claim on our lives and by that claim calls us with believers in all ages and all nations to seek and defend the good of all who bear his image. We set forth this declaration in light of the truth that is grounded in Holy Scripture, in natural human reason (which is itself, in our view, the gift of a beneficent God), and in the very nature of the human person. We call upon all people of goodwill, believers and non-
believers alike, to consider carefully and reflect critically on the issues we here address as we, with St. Paul, commend this appeal to everyone's conscience in the sight of God.

While the whole scope of Christian moral concern, including a special concern for the poor and vulnerable, claims our attention, we are especially troubled that in our nation today the lives of the unborn, the disabled, and the elderly are severely threatened; that the institution of marriage, already buffeted by promiscuity, infidelity and divorce, is in jeopardy of being redefined to accommodate fashionable ideologies; that freedom of religion and the rights of conscience are gravely jeopardized by those who would use the instruments of coercion to compel persons of faith to compromise their deepest convictions.

Because the sanctity of human life, the dignity of marriage as a union of husband and wife, and the freedom of conscience and religion are foundational principles of justice and the common good, we are compelled by our Christian faith to speak and act in their defense. In this declaration we affirm: 1) the profound, inherent, and equal dignity of every human being as a creature fashioned in the very image of God, possessing inherent rights of equal dignity and life; 2) marriage as a conjugal union of man and woman, ordained by God from the creation, and historically understood by believers and nonbelievers alike, to be the most basic institution in society and; 3 ) religious liberty, which is grounded in the character of God, the example of Christ, and the inherent freedom and dignity of human beings created in the divine image.

We are Christians who have joined together across historic lines of ecclesial differences to affirm our right - and, more importantly, to embrace our obligation - to speak and act in defense of these truths. We pledge to each other, and to our fellow believers, that no power on earth, be it cultural or political, will intimidate us into silence or acquiescence. It is our duty to proclaim the Gospel of our Lord and Savior Jesus Christ in its fullness, both in season and out of season. May God help us not to fail in that duty.

Life

So God created man in his own image, in the image of God he created him; male and female he created them. Genesis 1:27

I have come that they may have life, and have it to the full. John 10:10

Although public sentiment has moved in a pro-life direction, we note with sadness that proabortion ideology prevails today in our government. Many in the present administration want to make abortions legal at any stage of fetal development, and want to provide abortions at taxpayer expense. Majorities in both houses of Congress hold proabortion views. The Supreme Court, whose infamous 1973 decision in Roe v. Wade stripped the unborn of legal protection, continues to treat elective abortion as a fundamental constitutional right, though it has upheld as constitutionally permissible some limited restrictions on abortion. The President says that he wants to reduce the "need" for abortion-a commendable goal. But he has also pledged to make abortion more easily and widely available by eliminating laws prohibiting government funding, requiring waiting periods for women seeking abortions, and parental notification for abortions performed on minors. The elimination of these important and effective pro-life laws cannot reasonably be expected to do other than significantly increase the number of elective abortions by which the lives of countless children are snuffed out prior to birth. Our commitment to the sanctity of life is not a matter of partisan loyalty, for we recognize that in the thirty-six years since Roe $v$. Wade, elected officials and appointees of both major political parties have been complicit in giving legal sanction to what Pope John Paul II described as "the culture of death." We call on all officials in our country, elected and appointed, to protect and serve every member of our society, including the most marginalized, voiceless, and vulnerable among us.

A culture of death inevitably cheapens life in all its stages and conditions by promoting the belief that lives that are imperfect, immature or inconvenient are discardable. As predicted by many prescient persons, the cheapening of life that began with abortion has now metastasized. For example, human embryo-destructive research and its public funding are promoted in the name of science and in the cause of developing treatments and cures for diseases and injuries. The

President and many in Congress favor the expansion of embryo-research to include the taxpayer funding of so-called "therapeutic cloning." This would result in the industrial mass production of human embryos to be killed for the purpose of producing genetically customized stem cell lines and tissues. At the other end of life, an increasingly powerful movement to promote assisted suicide and "voluntary" euthanasia threatens the lives of vulnerable elderly and disabled persons. Eugenic notions such as the doctrine of lebensunwertes Leben ("life unworthy of life") were first advanced in the 1920s by intellectuals in the elite salons of America and Europe. Long buried in ignominy after the horrors of the mid-20th century, they have returned from the grave. The only difference is that now the doctrines of the eugenicists are dressed up in the language of "liberty," "autonomy," and "choice."

We will be united and untiring in our efforts to roll back the license to kill that began with the abandonment of the unborn to abortion. We will work, as we have always worked, to bring assistance, comfort, and care to pregnant women in need and to those who have been victimized by abortion, even as we stand resolutely against the corrupt and degrading notion that it can somehow be in the best interests of women to submit to the deliberate killing of their unborn children. Our message is, and ever shall be, that the just, humane, and truly Christian answer to problem pregnancies is for all of us to love and care for mother and child alike.

A truly prophetic Christian witness will insistently call on those who have been entrusted with temporal power to fulfill the first responsibility of government: to protect the weak and vulnerable against violent attack, and to do so with no favoritism, partiality, or discrimination. The Bible enjoins us to defend those who cannot defend themselves, to speak for those who cannot themselves speak. And so we defend and speak for the unborn, the disabled, and the dependent. What the Bible and the light of reason make clear, we must make clear. We must be willing to defend, even at risk and cost to ourselves and our institutions, the lives of our brothers and sisters at every stage of development and in every condition.

Our concern is not confined to our own nation. Around the globe, we are witnessing cases of genocide and "ethnic cleansing," the failure to assist those who are suffering as
innocent victims of war, the neglect and abuse of children, the exploitation of vulnerable laborers, the sexual trafficking of girls and young women, the abandonment of the aged, racial oppression and discrimination, the persecution of believers of all faiths, and the failure to take steps necessary to halt the spread of preventable diseases like AIDS. We see these travesties as flowing from the same loss of the sense of the dignity of the human person and the sanctity of human life that drives the abortion industry and the movements for assisted suicide, euthanasia, and human cloning for biomedical research. And so ours is, as it must be, a truly consistent ethic of love and life for all humans in all circumstances.

## Marriage

The man said, "This is now bone of my bones and flesh of my flesh; she shall be called woman, for she was taken out of man." For this reason a man will leave his father and mother and be united to his wife, and they will become one flesh. Genesis 2:23-24

This is a profound mystery-but I am talking about Christ and the church. However, each one of you also must love his wife as he loves himself, and the wife must respect her husband. Ephesians 5:32-33

In Scripture, the creation of man and woman, and their one-flesh union as husband and wife, is the crowning achievement of God's creation. In the transmission of life and the nurturing of children, men and women joined as spouses are given the great honor of being partners with God Himself. Marriage then, is the first institution of human societyindeed it is the institution on which all other human institutions have their foundation. In the Christian tradition we refer to marriage as "holy matrimony" to signal the fact that it is an institution ordained by God, and blessed by Christ in his participation at a wedding in Cana of Galilee. In the Bible, God Himself blesses and holds marriage in the highest esteem.

Vast human experience confirms that marriage is the original and most important institution for sustaining the health, education, and welfare of all persons in a society. Where marriage is honored, and where there is a flourishing marriage culture, everyone
benefits-the spouses themselves, their children, the communities and societies in which they live. Where the marriage culture begins to erode, social pathologies of every sort quickly manifest themselves.

Unfortunately, we have witnessed over the course of the past several decades a serious erosion of the marriage culture in our own country. Perhaps the most telling - and alarming-indicator is the out-of-wedlock birth rate. Less than fifty years ago, it was under 5 percent. Today it is over 40 percent. Our society - and particularly its poorest and most vulnerable sectors, where the out-of-wedlock birth rate is much higher even than the national average - is paying a huge price in delinquency, drug abuse, crime, incarceration, hopelessness, and despair. Other indicators are widespread non-marital sexual cohabitation and a devastatingly high rate of divorce.

We confess with sadness that Christians and our institutions have too often scandalously failed to uphold the institution of marriage and to model for the world the true meaning of marriage. Insofar as we have too easily embraced the culture of divorce and remained silent about social practices that undermine the dignity of marriage we repent, and call upon all Christians to do the same.

To strengthen families, we must stop glamorizing promiscuity and infidelity and restore among our people a sense of the profound beauty, mystery, and holiness of faithful marital love. We must reform ill-advised policies that contribute to the weakening of the institution of marriage, including the discredited idea of unilateral divorce. We must work in the legal, cultural, and religious domains to instill in young people a sound understanding of what marriage is, what it requires, and why it is worth the commitment and sacrifices that faithful spouses make.

The impulse to redefine marriage in order to recognize same-sex and multiple partner relationships is a symptom, rather than the cause, of the erosion of the marriage culture. It reflects a loss of understanding of the meaning of marriage as embodied in our civil and religious law and in the philosophical tradition that contributed to shaping the law. Yet it is critical that the impulse be resisted, for yielding to it would mean abandoning the possibility of restoring a sound understanding of marriage and, with it, the hope of
rebuilding a healthy marriage culture. It would lock into place the false and destructive belief that marriage is all about romance and other adult satisfactions, and not, in any intrinsic way, about procreation and the unique character and value of acts and relationships whose meaning is shaped by their aptness for the generation, promotion and protection of life. In spousal communion and the rearing of children (who, as gifts of God, are the fruit of their parents' marital love), we discover the profound reasons for and benefits of the marriage covenant.

We acknowledge that there are those who are disposed towards homosexual and polyamorous conduct and relationships, just as there are those who are disposed towards other forms of immoral conduct. We have compassion for those so disposed; we respect them as human beings possessing profound, inherent, and equal dignity; and we pay tribute to the men and women who strive, often with little assistance, to resist the temptation to yield to desires that they, no less than we, regard as wayward. We stand with them, even when they falter. We, no less than they, are sinners who have fallen short of God's intention for our lives. We, no less than they, are in constant need of God's patience, love and forgiveness. We call on the entire Christian community to resist sexual immorality, and at the same time refrain from disdainful condemnation of those who yield to it. Our rejection of $\sin$, though resolute, must never become the rejection of sinners. For every sinner, regardless of the sin, is loved by God, who seeks not our destruction but rather the conversion of our hearts. Jesus calls all who wander from the path
of virtue to "a more excellent way." As his disciples we will reach out in love to assist all who hear the call and wish to answer it.

We further acknowledge that there are sincere people who disagree with us, and with the teaching of the Bible and Christian tradition, on questions of sexual morality and the nature of marriage. Some who enter into same-sex and polyamorous relationships no doubt regard their unions as truly marital. They fail to understand, however, that marriage is made possible by the sexual complementarity of man and woman, and that the comprehensive, multi-level sharing of
life that marriage is includes bodily unity of the sort that unites husband and wife biologically as one. This is because the body is no mere extrinsic instrument of the human
person, but truly part of the personal reality of the human being. Human beings are not merely centers of consciousness or emotion, or minds, or spirits, inhabiting non-personal bodies. The human person is a dynamic unity of body, mind, and spirit. Marriage is what one man and one woman establish when, forsaking all others and pledging lifelong commitment, they found a sharing of life at every level of being-the biological, the emotional, the dispositional, the rational, the spiritual-on a commitment that is sealed, completed and actualized by loving sexual intercourse in which the spouses become one flesh, not in some merely metaphorical sense, but by fulfilling together the behavioral conditions of procreation. That is why in the Christian tradition, and historically in Western law, consummated marriages are not dissoluble or annullable on the ground of infertility, even though the nature of the marital relationship is shaped and structured by its intrinsic orientation to the great good of procreation.

We understand that many of our fellow citizens, including some Christians, believe that the historic definition of marriage as the union of one man and one woman is a denial of equality or civil rights. They wonder what to say in reply to the argument that asserts that no harm would be done to them or to anyone if the law of the community were to confer upon two men or two women who are living together in a sexual partnership the status of being "married." It would not, after all, affect their own marriages, would it? On inspection, however, the argument that laws governing one kind of marriage will not affect another cannot stand. Were
it to prove anything, it would prove far too much: the assumption that the legal status of one set of marriage relationships affects no other would not only argue for same sex partnerships; it could be asserted with equal validity for polyamorous partnerships, polygamous households, even adult brothers, sisters, or brothers and sisters living in incestuous relationships. Should these, as a matter of equality or civil rights, be recognized as lawful marriages, and would they have no effects on other relationships? No. The truth is that marriage is not something abstract or neutral that the law may legitimately define and re-define to please those who are powerful and influential.

No one has a civil right to have a non-marital relationship treated as a marriage. Marriage is an objective reality-a covenantal union of husband and wife-that it is the duty of the law to recognize and support for the sake of justice and the common good. If it fails to do so,
genuine social harms follow. First, the religious liberty of those for whom this is a matter of conscience is jeopardized. Second, the rights of parents are abused as family life and sex education programs in schools are used to teach children that an enlightened understanding recognizes as "marriages" sexual partnerships that many parents believe are intrinsically nonmarital and immoral. Third, the common good of civil society is damaged when the law itself, in its critical pedagogical function, becomes a tool for eroding a sound understanding of marriage on which the flourishing of the marriage culture in any society vitally depends. Sadly, we are today far from having a thriving marriage culture. But if we are to begin the critically important process of reforming our laws and mores to rebuild such a culture, the last thing we can afford to do is to re-define marriage in such a way as to embody in our laws a false proclamation about what marriage is.

And so it is out of love (not "animus") and prudent concern for the common good (not "prejudice"), that we pledge to labor ceaselessly to preserve the legal definition of marriage as the union of one man and one woman and to rebuild the marriage culture. How could we, as Christians, do otherwise? The Bible teaches us that marriage is a central part of God's creation covenant. Indeed, the union of husband and wife mirrors the bond between Christ and his church. And so just as Christ was willing, out of love, to give Himself up for the church in a complete sacrifice, we are willing, lovingly, to make whatever sacrifices are required of us for the sake of the inestimable treasure that is marriage.

## Religious Liberty

The Spirit of the Sovereign LORD is on me, because the LORD has anointed me to preach good news to the poor. He has sent me to bind up the brokenhearted, to proclaim freedom for the captives and release from darkness for the prisoners. Isaiah 61:1

Give to Caesar what is Caesar's, and to God what is God's. Matthew 22:21

The struggle for religious liberty across the centuries has been long and arduous. Religious liberty is not a novel idea or recent development, but is grounded in the
character of God Himself, the God who is most fully known in the life and work of Jesus Christ. Determined to follow Jesus faithfully in life and death, the early Christians appealed to the manner in which the Incarnation had taken place: "Did God send Christ, as some suppose, as a tyrant brandishing fear and terror? Not so, but in gentleness and meekness..., for compulsion is no attribute of God" (Epistle to Diognetus 7.3-4). Thus the right to religious freedom has its foundation in the example of Christ Himself and in the very dignity of the human person created in the image of God-a dignity, as our founders proclaimed, inherent in every human, and knowable by all in the exercise of right reason.

Christians confess that God alone is Lord of the conscience. Immunity from religious coercion is the cornerstone of an unconstrained conscience. No one should be compelled to embrace any religion against his will, nor should persons of faith be forbidden to worship God according to the dictates of conscience or to express freely and publicly their deeply held religious convictions. What is true for individuals applies to religious communities as well.

It is ironic that those who today assert a right to kill the unborn, aged and disabled and also a right to engage in immoral sexual practices, and even a right to have relationships integrated around these practices be recognized and blessed by law-such persons claiming these "rights" are very often in the vanguard of those who would trample upon the freedom of others to express their religious and moral commitments to the sanctity of life and to the dignity of marriage as the conjugal union of husband and wife.

We see this, for example, in the effort to weaken or eliminate conscience clauses, and therefore to compel pro-life institutions (including religiously affiliated hospitals and clinics), and pro-life physicians, surgeons, nurses, and other health care professionals, to refer for abortions and, in certain cases, even to perform or participate in abortions. We see it in the use of antidiscrimination statutes to force religious institutions, businesses, and service providers of various sorts to comply with activities they judge to be deeply immoral or go out of business. After the judicial imposition of "same-sex marriage" in Massachusetts, for example, Catholic Charities chose with great reluctance to end its century-long work of helping to place orphaned children in good homes rather than comply with a legal mandate that it place children in same-sex households in violation of

Catholic moral teaching. In New Jersey, after the establishment of a quasi-marital "civil unions" scheme, a Methodist institution was stripped of its tax exempt status when it declined, as a matter of religious conscience, to permit a facility it owned and operated to be used for ceremonies blessing homosexual unions. In Canada and some European nations, Christian clergy have been prosecuted for preaching Biblical norms against the practice of homosexuality. New hate-crime laws in America raise the specter of the same practice here.

In recent decades a growing body of case law has paralleled the decline in respect for religious values in the media, the academy and political leadership, resulting in restrictions on the free exercise of religion. We view this as an ominous development, not only because of its threat to the individual liberty guaranteed to every person, regardless of his or her faith, but because the trend also threatens the common welfare and the culture of freedom on which our system of republican government is founded. Restrictions on the freedom of conscience or the ability to hire people of one's own faith or conscientious moral convictions for religious institutions, for example, undermines the viability of the intermediate structures of society, the essential buffer against the overweening authority of the state, resulting in the soft despotism Tocqueville so prophetically warned of. ${ }^{1}$ Disintegration of civil society is a prelude to tyranny.

As Christians, we take seriously the Biblical admonition to respect and obey those in authority. We believe in law and in the rule of law. We recognize the duty to comply with laws whether we happen to like them or not, unless the laws are gravely unjust or require those subject to them to do something unjust or otherwise immoral. The biblical purpose of law is to preserve order and serve justice and the common good; yet laws that are unjust-and especially laws that purport to compel citizens to do what is unjust-undermine the common good, rather than serve it.

Going back to the earliest days of the church, Christians have refused to compromise their proclamation of the gospel. In Acts 4, Peter and John were ordered to stop preaching. Their answer was, "Judge for yourselves whether it is right in God's sight to obey you rather than God. For we cannot help speaking about what we have seen and heard." Through the centuries, Christianity has taught that civil disobedience is not only
permitted, but sometimes required. There is no more eloquent defense of the rights and duties of religious conscience than the one offered by Martin Luther King, Jr., in his Letter from a Birmingham Jail. Writing from an explicitly Christian perspective, and citing Christian writers such as Augustine and Aquinas, King taught that just laws elevate and ennoble human beings because they are rooted in the moral law whose ultimate source is God Himself. Unjust laws degrade human beings. Inasmuch as they can claim no authority beyond sheer human will, they lack any power to bind in conscience. King's willingness to go to jail, rather than comply with legal injustice, was exemplary and inspiring.

Because we honor justice and the common good, we will not comply with any edict that purports to compel our institutions to participate in abortions, embryo-destructive research, assisted suicide and euthanasia, or any other anti-life act; nor will we bend to any rule purporting to force us to bless immoral sexual partnerships, treat them as marriages or the equivalent, or refrain from proclaiming the truth, as we know it, about morality and immorality and marriage and the family. We will fully and ungrudgingly render to Caesar what is Caesar's. But under no circumstances will we render to Caesar what is God's.
