PLAINTIFFS' UNOPPOSED MOTION TO FILE DOCUMENT UNDER SEAL

Pursuant to Local Rule 5.2, Plaintiffs Janet Jenkins and Isabella Miller-Jenkins move for leave to file the attached document under seal as Exhibit 9 to Plaintiffs' Revised Second Motion to Compel Defendants Liberty Counsel, Inc. and Rena Lindevaldsen to Comply with Plaintiffs' First Requests for Production, ECF 591. In support, Plaintiffs state the following:

1. On September 14, 2020, the Court ordered Plaintiffs to "submit a revised motion to compel ... after review of the Defendants' submission of the affidavit describing discovery procedures. Plaintiffs shall identify documents or areas of discovery not included in Defendants' discovery responses. In addition, Plaintiffs shall identify sections of the privilege log which they claim to be inadequate." Op. & Order 3–4, ECF 563.

2. Plaintiffs filed their revised second motion to compel on November 11, 2020. *See* ECF 591. In their discussion of the inadequacy of Defendants' privilege logs, Plaintiffs provide the example of an email Lindevaldsen redacted as privileged attorney–client communications but which Defendant Kenneth Miller produced unredacted, revealing that much of those redacted communications are not privileged attorney–client communications. *See* Pls.' Revised Second Mot. to Compel 19, ECF 591. To Plaintiffs' understanding, Kenneth Miller produced that email (and others) because he received them from the government, which had seized them from Lisa Miller's email account as early as August 10, 2010. *See* Ex. 1: Search and Seizure Warrant,

United States v. Miller, No. 2:10-mj-74 (D. Vt. Aug. 23, 2010), ECF 14; *see also* Ex. 2: Docket Report, *United States v. Miller*, No. 2:10-mj-74 (D. Vt.) (showing search warrant was unsealed July 27, 2011). In an October 2, 2020 letter, Plaintiffs provided Defendants this example with a copy of the email Kenneth Miller produced. *See* Soto Letter, ECF 591-3.

3. On October 30, 2020, Defendants told Plaintiffs “it ha[d] come to [their] attention that the documents seized from Lisa Miller’s email account contain several communications that are privileged” and that Defendants “are undertaking a comprehensive review and will provide [Plaintiffs] with a list of communications which are privileged and which should be ‘clawed back.’” Soto–Mihet Emails 2–3, ECF 591-2.

4. The parties agreed to seek leave to file under seal any email between Lisa and Liberty Counsel that were seized from her email account without prejudice to Plaintiffs’ challenge to any privilege assertion. *See id.* at 1–2.

5. Pursuant to Local Rule 7(a)(7), Plaintiffs certify that they made a good-faith attempt to obtain Defendants’ agreement to the requested relief. Defendants do not oppose this motion. *See id.*

CONCLUSION

The motion should be granted and Exhibit 9 should be filed under seal.


