DECLARATION OF ROBERT E. EASTON

I, Robert E. Easton, do hereby declare as follows:

1. I currently serve as Director, Office of Litigation Counsel, in the Department of Defense ("DoD") Office of General Counsel. I have held this position since 2006. In this capacity, I supervise the conduct and oversight of litigation of Departmental significance, including matters involving senior DoD leaders, and coordinate litigation among the Military Departments, Defense Agencies, and Field Activities.

2. In the exercise of my official duties, I have been made aware of this lawsuit and the three other cases involving the March 12, 2019 DoD Policy on Military Service by Transgender Persons and Persons with Gender Dysphoria (“DoD Transgender Service Policy”).

3. I submit this declaration in response to the Court’s July 25, 2020 and September 29, 2020 orders directing the government to provide documents to the Court for *in camera* review. I base this declaration on my personal knowledge and information made available to me in the performance of my official duties.

4. The Court directed DoD to submit for *in camera* review certain communications from July 26, 2017, until September 14, 2017, that had been listed on the DoD privilege log as withheld from production pursuant to the deliberative process privilege.

5. Based on my review of the relevant documents, I have determined that the following documents submitted with this Declaration were created as part of DoD’s decision-making processes and reflect the deliberative process undertaken by DoD and military personnel in developing and implementing DoD’s policy on military service by transgender individuals or individuals diagnosed with or having a history of gender dysphoria. These documents specifically reflect processes and deliberations from July 26, 2017, until September 14, 2017, that mention, relate to, or refer to this policy. Accordingly, DoD invokes the deliberative process privilege over each of these documents. Where equities of the military Services are jointly implicated in a document, DoD hereby invokes the deliberative process privilege over the deliberative material in the document. Where appropriate, DoD will produce redacted versions of documents where segregation is possible and the content is not deliberative.

6. There are a number of categories of documents that are subject to the

deliberative process privilege. Each numbered paragraph below addresses a specific category of such documents. Bulleted subparagraphs address any subcategories of documents.

DOCUMENTS SUBJECT TO THE DELIBERATIVE PROCESS PRIVILEGE

7. The first category of documents consists of emails discussing the process for formulating the interim guidance on transgender military service developed between July 26, 2017, and September 14, 2017.¹ DoD00031826, DoD00031837, DoD00093932, DoD00093934, and DoD00093938 are emails between Mr. Tony Kurta, who was performing the duties of the Undersecretary of Defense for Personnel and Readiness during that time period, Mr. Paul Koffsky, a senior DoD attorney performing the duties of the DoD General Counsel during that time period, Mr. William Bushman, a senior DoD official in the Office of the Secretary of Defense (“OSD”), and Lieutenant Colonel Robert Guillen, a Military Assistant to the General Counsel, discussing the timeline and how best to coordinate the interim guidance with the Services. These documents are pre-decisional. The discussions and deliberations reflected in these emails occurred prior to the issuance of the interim guidance on September 14, 2017. They are also deliberative. They reflect senior DoD officials’ opinions and recommendations concerning how DoD’s policy coordination process should proceed and include proposed policy options and internal discussions on Secretary of Defense James Mattis’s priorities.

8. The next category concerns edits from personnel within OSD, the Army, Navy, Air Force, Coast Guard, and Joint Staff on the draft interim guidance and draft terms of reference.² In some cases, these edits originated from senior personnel from these offices. These documents are pre-decisional. The drafts of the interim guidance and terms of reference were created before the issuance of the final documents on September 14, 2017, and the

discussions, edits, recommendations, and deliberations regarding those drafts also occurred prior to the final issuance of the documents. These documents are also deliberative. They reflect edits and recommendations from officials regarding the proposed content of the interim guidance and terms of reference and include the proposed edits. This category includes the following:

- DoD00031850 and DoD00032705 are edits, comments, and deliberative discussions between Mr. Bushman and Mr. Koffsky reflecting the thoughts of the Secretary of Defense in formulating what became the September 14, 2017 interim guidance. DoD00032705 has been separately redacted pursuant to attorney-client privilege.
- DoD00002407, DoD00002410, and AF_00029413_AF2 are copies of a memorandum from then-Secretary of the Air Force Heather Wilson reflecting comments and revisions to the draft interim guidance. In particular, the memorandum sets forth the Air Force's proposed edits to the draft interim guidance, along with rationale for those recommended edits.
- DoD00002408 and DoD00002411 are copies of a handwritten note that Secretary Wilson added to the bottom of her memorandum reflecting her personal views and recommendations regarding the draft interim guidance.
- DoD00002406, DoD00002409, DoD00009652, DoD00009653, DoD00011423, DoD00093840, DoD00026887, AF_00008110, and AF_00008110_AF2 are email deliberations between senior DoD officials including Ms. Stephanie Miller, a senior official in the Office of the Undersecretary of Defense for Personnel and Readiness ("OUSDP&R"), Mr. Bushman, Mr. Lernes Hebert, a senior DoD official serving in OUSDP&R, and Mr. Kurta, responding internally to the memorandum from the Air Force Secretary. These emails contain transcribed text of Secretary Wilson's

handwritten note containing her views and recommendations regarding the draft interim guidance.

- Army_10000312, Army_10001145.0001, Army_10001435, Army_10001739.0001, Army_10002491.0441, Army_10003800.0001, Army_10003801.0001, Army_10004327, Army_10004327.0001, Army_10004375.0001, Army_10004382.0001, Army_10004386.0002, Army_10004511.0001, Army_10004519.0001, Army_10005218.0001, Army_10013904.0001, Army_10014123.0001, DoD0009650 and DoD00026886 are copies of Army comments and recommended revisions to the draft interim guidance.
- Navy_00049302, Navy_00049293, Navy_00049297, Navy_00049339, Navy_00049340, Navy_00049409, Navy_00049411, Navy_00049421, Navy_00049430, Navy_00049440, Navy_00064325, Navy_00064326, Navy_00064332, Navy_00064345, and Navy_00064333 are Navy edits, recommendations, and comments to the draft interim guidance memorandum.
- AF_00029415_AF2 is an Air Force document providing comments and recommendations on the draft interim guidance memorandum.
- CJCS00000762 is a Joint Staff document providing comments, edits, and the rationale for edits to both the draft interim guidance and the draft terms of reference.

9. The next category consists of a single email chain, document DoD00093430, containing internal OSD and OUSD(P&R) deliberations regarding draft documents to establish the DoD Panel of Experts. The email chain reflects communications from Mr. Bushman to Mr. Kurta regarding the specific additional information that Mr. Kevin Sweeney, Chief of Staff to the Secretary of Defense, wanted to add to the drafts before they were sent to Secretary Mattis for review. This conversation is pre-decisional. It preceded the Secretary of Defense's

ultimate decision to establish the Panel of Experts reflected in the September 14, 2017 terms of reference. The conversation is also deliberative. It shows the mental impressions, thoughts, and opinions of senior DoD officials as the Department developed the necessary details to establish the Panel.

10. The next category includes talking points, holding statements, and responses to questions from the media. Within DoD, talking points are developed by staff to provide senior leaders with accurate facts and policy positions so that DoD speaks with one voice to its components, the Services, other parts of the U.S. Government, and the public. These documents are in draft form and were not approved for release by DoD leadership. This category includes the following:

- DoD00093823 and DoD00093867 reflect an email conversation between Mr. Bushman and Ms. Dana White, the Assistant to the Secretary of Defense for Public Affairs, in which Mr. Bushman provided Ms. White with draft talking points for use if the media asked about the interim guidance.
- DoD00124372, DoD00002326, DoD00002329, DoD00002332 (including redline edits from Ms. Stephanie Miller), DoD00002363 (containing redline edits from Ms. Stephanie Barna), DoD00002366, DoD00002369, DoD00002371, DoD00002373, DoD00007023, DoD00008390, DoD00008394, DoD00010972, and DoD00010974 are copies of a draft statement to be sent to the media, as well as proposed responses to anticipated questions from the media after issuance of the interim guidance.
- DoD00093581 is a draft statement for Secretary Mattis in response to the President's August 25, 2017 Memorandum exchanged between senior OSD officials on September 6, 2017. It lays out the Secretary's priorities and includes his proposed responses to questions should he receive them. DoD00093578 is a document

named “press one-liners” also exchanged between senior officials in OSD on September 6, 2017, that contains the same information as DoD00093581 but also contains non-responsive talking points on several other topics including Afghanistan, Iraq, Syria, Hurricane Harvey, and North Korea. DoD00093578 is labeled at the top of each page with the words “DRAFT 2.0 – 0924, 6 SEPT 2017” to mark the time and date of the latest iteration of the working draft. These documents are pre-decisional. They contain draft talking points for Secretary Mattis before those talking points were finalized. Further, the documents were drafted before DoD issued its September 14, 2017 interim guidance. These documents are also deliberative. They shed light on the Secretary of Defense’s thought processes on several important topics, including the interim guidance.

- DoD00094291, DoD00094301, and DoD00094335 reflect an email conversation between Mr. Bushman and Ms. White regarding a potential draft statement by Secretary Mattis on the interim guidance. These communications reflect Mr. Bushman asking Ms. White for her opinion on the draft statement and some edits to the statement based on media reporting. They are pre-decisional. The drafts, as well as the edits, were developed before the proposed statement was issued by DoD. They are also deliberative. They show the process of developing a statement for the media and contain edits and recommended changes on that draft statement. These documents have been separately redacted pursuant to attorney-client privilege.

11. The next category consists of 50 copies of a draft statement from the Secretary of Defense on the issuance of the interim guidance as noted in Paragraph 10. DoD00002556, DoD00002558, DoD00004638, DoD00011445, DoD00011447, DoD00026931, DoD00031908, DoD00031911, DoD00032185, DoD00033709, DoD00033751, DoD00033767, DoD00033777,

DoD00033785, DoD00033795, DoD00033807, DoD00033811, DoD00034597, DoD00034634, DoD00034644, DoD00034727, DoD00034732, DoD00034875, DoD00039222, DoD00039240, DoD00039262, DoD00042887, DoD00084428, DoD00094069, DoD00094072, DoD00094327, DoD00094336, DoD00094429, DoD00094432, DoD00094594, DoD00094597, DoD00094600, DoD00094603, DoD00094687, DoD00094733, DoD00094736, DoD00033690, DoD00042418, DoD00042423, DoD00042433, DoD00042435, DoD00042438 DoD00085320, DoD00094165, and DoD00094830 are draft versions of a public statement prepared for the Secretary. These documents are pre-decisional. They precede Secretary Mattis' public statement regarding DoD's issuance of the September 14, 2017 interim guidance and terms of reference. They are also deliberative. These are drafts of a public statement assembled for the Secretary that contain varying language and recommended edits to the draft statement.

12. The next category of documents concerns a draft letter to the President. DoD00033944 and DoD00033954 are draft copies of a letter from Secretary Mattis to the President describing actions that the Secretary intended to take to develop the Department's policy on military service by transgender personnel and individuals with gender dysphoria. These draft copies of the letter are pre-decisional to the formation of the Panel of Experts and the release of the interim guidance, and they were never made public. They are also deliberative. They show the mental impressions, thoughts, and opinions of the Secretary of Defense and his staff as DoD worked to respond to the President and provide information to the Force.

13. The final category consists of documents that reflect deliberations by OSD staff concerning subjects unrelated to transgender service. Document DoD00002354 is an email thread in which a public affairs official mentions his work on transgender issues only in passing. DoD00002709 contains deliberations and communications regarding the transgender policy as part of an email thread that mainly concerns a separate personnel policy. It is redacted

under the attorney-client privilege and presidential communications privilege. DoD00083846 contains four pages of draft talking points on a number of then-current DoD and international issues, of which transgender policy is only one.

14. As discussed in my prior declarations, release of DoD information protected by the deliberative process privilege in this case would have a substantial and immediate chilling effect on policy deliberation and development within DoD writ large. The DoD decision-making apparatus relies on open and candid conversations among leadership, advisors, and policy analysts to advise and inform DoD policy makers across the military Services on various courses of action for any decision. Matters of national security frequently present multiple courses of action that require careful and delicate balancing of equities and priorities against the need to serve national defense interests, and leaders within the Department encourage open and candid discussions about the merits of such actions. Opinions identifying risks or areas of concern are critical to the integrity and viability of the military decision-making process.

15. In addition, the geographically dispersed nature of DoD activities and the high operational tempo with which many of the Department's activities are conducted mean that deliberative and pre-decisional conversations frequently occur via email. Leaders across the Department routinely solicit feedback, thoughts, and opinions on highly sensitive topics, including those with national-security implications, using email so that those who need to review and weigh-in on a decision can do so in real time regardless of their physical location.

16. The forced release of these types of delicate and candid communications would directly and immediately impair open and frank conversations at both the operational and strategic levels. If DoD personnel knew that their thoughts, impressions, and opinions, including those reflected in draft documents, whether related to DoD transgender policy or otherwise, would be open to scrutiny, they may hesitate to provide their genuine positions on


potential courses of action, not only as to military personnel decisions but regarding any politically sensitive decision that DoD faces in the future, for fear that these discussions could be revealed to wider audiences. The lack of essential input would degrade DoD's decision-making process and could expose the nation to greater overall risk.

17. These risks are heightened with respect to the documents discussed in this declaration. These documents involve discussions among the highest levels of the military and the Department including, for example, the Secretary of Defense and his staff, as well as the Secretary of the Air Force. The potential consequences for national security of chilling the decision-making process at that level are significant and should be given due weight and consideration.

18. Finally, the disclosure of deliberative, pre-decisional input, analysis, and opinions from these individuals would breach DoD's commitment to maintain the confidentiality of participants' honest deliberations regarding the sensitive and complex topic of transgender service. This would irreparably harm DoD's ability to obtain candid and open input on any similarly sensitive subject in the future, not just regarding military service by transgender individuals.

Pursuant to 28 U.S.C. § 1746, I declare under penalty of perjury that the foregoing is true and correct.

DECLARATION OF BRIAN JUDGE

I, Brian Judge, make the following declaration:

1. I am employed by the United States Coast Guard within the Department of Homeland Security and am located in Washington, D.C. I have been employed by the U.S. Coast Guard as a civilian for over six years. I also served on active duty in the Coast Guard for over 24 years. I am currently the Chief of the Office of Claims and Litigation within the Office of the Judge Advocate General. As the Chief of the Office of Claims and Litigation, my duties include advising Coast Guard programs on matters that are or may be involved in litigation and providing any necessary litigation support to the Department of Justice.

2. In the exercise of my official duties, I have been made aware of this lawsuit and the related cases involving the Coast Guard and Department of Defense (“DoD”) Policy on Military Service by Transgender Persons and Persons with Gender Dysphoria. I base this declaration on

my personal knowledge and on information made available to me in the performance of my official duties.

3. I submit this declaration in response to the Court's Order following the September 29, 2020 status conference directing the government to provide documents to the Court for *in camera* review. Dkt. 617.

4. The Court directed Defendants to submit for *in camera* review all documents withheld under the deliberative process privilege from the time period July 26, 2017 to September 14, 2017. Dkt. 617 at 2.

5. Within the relevant time period of July 26, 2017 to September 14, 2017, the Coast Guard asserts the deliberative process privilege over three documents with the following document identification numbers: USCG 00007063, USCG 00008855, and USCG 00009301.


6. USCG 00007063, USCG 00008855, and USCG 00009301 are identical copies of a working draft white paper titled "Coast Guard Response to Joint Transgender Workgroup Recommendations," with markups in track changes containing numerous suggested edits and substantive comments. The suggested edits and substantive comments show deliberations by Coast Guard officials as they discuss the material that they believe should be included in the document. This document is being withheld in its entirety because the entire document is a non-final working draft containing suggested edits and substantive comments and no part of the document can be meaningfully segregated from non-deliberative material. This draft white paper is predecisional to the creation of the final policy.

7. This draft white paper is the quintessential example of the type of documents that the deliberative process privilege protects from disclosure. This document is integrally related to policy formation. Coast Guard officials must have the ability to review draft white papers and

provide suggested edits and substantive comments to ensure the Coast Guard maintains the highest quality of decision-making. This is particularly true with the development of military personnel policy where the Coast Guard maintains tight alignment with the military personnel policies of the Department of Defense, but must be able to freely and frankly discuss and resolve differences with their Department of Defense counterparts that may arise because of the Coast Guard's different force structure, authorities, and missions. If Coast Guard officials knew that their suggested edits and substantive comments to a draft white paper would be revealed, they would be less likely to provide their candid assessment, which would harm the quality of the Coast Guard's decision-making process. Therefore, the disclosure of this privileged document would result in detrimental and irreparable harm to the open and independent review and discussion among those individuals involved in developing policy in the future. Finally, release of draft white papers would cause public confusion, as it could reveal information that may not ultimately have been included in the final Department of Defense or Coast Guard policies or guidance.

Pursuant to 28 U.S.C. § 1746, I declare under penalty of perjury that the forgoing is true and correct to the best of my knowledge and belief.
