1 In advance of the November 30, 2020 status hearing, the parties respectfully submit the
2 following Joint Status Report.

3 Pursuant to this Court’s Order dated October 28, 2020 (Dkt. No. 629), the Government is

- 15 • December 11, 2020: Documents dated September 14, 2017 to November 17, 2017
16 submitted for *in camera* review along with any accompanying declarations
- 17 • December 18, 2020: Production of documents dated July 13, 2015 to June 30, 2016
18 to Plaintiffs
- 19 • December 23, 2020: Documents dated July 13, 2015 to June 30, 2016 submitted for
20 *in camera* review along with any accompanying declarations
