**DEFENDANT ARNEIKA S. SMITH'S ANSWER AND RESPONSIVE
PLEADING TO PLAINTIFF'S COMPLAINT**

COMES NOW Arneika S. Smith, misnamed in the Complaint as Aretha Smith, Defendant in the above-styled action, by and through her undersigned counsel of record, and presents her Answer and Responsive Pleading, including defenses and objections, to Plaintiff's first Complaint as follows:

FIRST DEFENSE

Plaintiff failed to state a claim for which relief may be granted as to all or some of Plaintiff's claims.

SECOND DEFENSE

Defendant asserts the affirmative defenses of lack of subject matter jurisdiction and lack of personal jurisdiction over this Defendant.

THIRD DEFENSE

Plaintiff's claims are barred by Eleventh Amendment immunity, state sovereign immunity, good faith immunity, and/or qualified immunity.

FOURTH DEFENSE

Any action taken by this Defendant, relative to the allegations in Plaintiff's Complaint, was a bona fide good faith decision, for good cause.

FIFTH DEFENSE

Any injuries or damages allegedly sustained by Plaintiff were directly and proximately caused by the actions of Plaintiff or others and not this Defendant.

SIXTH DEFENSE

No act or omission of Defendant caused or contributed to any of Plaintiff's alleged injuries, damages, or deprivations.

SEVENTH DEFENSE

At all times relevant to Plaintiff's allegations, Defendant acted reasonably and in good faith and Plaintiff brings this action with unclean hands. The Defendant affirmatively asserts that she engaged in good faith efforts to comply with all legal requirements.

EIGHTH DEFENSE

Plaintiff fails to allege a violation of a clearly established constitutional right against this Defendant.

NINETH DEFENSE

To the extent the Complaint may be construed to name Defendant in her official capacity, she asserts the affirmative defense of Eleventh Amendment sovereign immunity.

TENTH DEFENSE

Defendant at no time relevant to the allegations in the instant Complaint acted with intent to harm or injure Plaintiff, nor has she acted with reckless or callous disregard for the constitutional rights of Plaintiff. For these reasons, Plaintiff has no cause of action against her pursuant to 42 U.S.C. § 1983.

ELEVENTH DEFENSE

The portions of Plaintiff's Complaint consisting of legal arguments and arguments regarding the evidence should be stricken under FED. R. CIV. P. 12(f).

TWELFTH DEFENSE

Plaintiff is not entitled to liquidated or punitive damages because Defendant at no time engaged in willful misconduct and at no time engaged in any practice or conduct with malice or reckless indifference Plaintiff's rights..

THIRTEENTH DEFENSE

Defendant cannot be held liable in this civil rights lawsuit for actions of other persons in which she did not participate, did not direct, authorize, and did not ratify.

FOURTEENTH DEFENSE

Defendant denies Plaintiff has been deprived by her of any rights, privileges, or immunities secured by the Constitution of the United States or the State of Georgia, or otherwise by law.

FIFTEENTH DEFENSE

Plaintiff failed to exhaust administrative remedies as required by the Prison Legal Reform Act or other legal provisions.

SIXTEENTH DEFENSE

Plaintiff's claims for punitive damages are not recoverable against Defendant under the statutory provisions with which Plaintiff purports to make his claims.

SEVENTEENTH DEFENSE

Defendant raises the defense that the Complaint is barred by the statute of limitations to the extent subsequent discovery demonstrates any claim was not timely filed.

EIGHTEENTH DEFENSE

Without waiving the forgoing Defenses, Defendant A. Smith responds to the specific allegations of the Complaint as follows:
