**DEFENDANT LINDA WALL’S MEMORANDUM**  
**REGARDING STAY OF THE REMAINDER OF THE CASE**

Pursuant to the Court’s April 16, 2021 Order (Dkt. 686), Defendant Linda Wall hereby submits this Memorandum “as to whether the remainder of the case should either proceed to motions or trial or be stayed pending resolution of the criminal case involving Lisa Miller.”

In light of the stay entered in the April 16 Order as to all claims against Lisa Miller, Wall states that **the remainder of the case should be stayed pending resolution of the criminal case involving Lisa Miller**. The stay should be global, not piecemeal. When the Court previously stayed the case in 2015 pending resolution of the criminal case involving Defendant Philip Zodhiates, the Court’s stay encompassed all claims against all Defendants. Dkt. 192.

Wall reserves all rights to seek—after the present stay is lifted and in the (however unlikely) event any claims against Wall survive summary judgment—severance, including for trial, from any defendants who may be criminally convicted and/or assert their Fifth Amendment rights against self-incrimination and are still in the case after resolution of any summary-judgment motions. See Dkt. 659 at 9.
