**STIPULATION TO CONTINUE
ORAL ARGUMENT SET FOR
JULY 28, 2021**

23 On June 30, 2021, this Court scheduled oral argument on Plaintiff Russell B. Toomey's
24 Motion for Entry of an Order Compelling the Production of Documents ("the Motion") (Doc.
25 202) for July 28, 2021, at 11:00 a.m. (*See* Doc. 215.) The Motion seeks to compel the production of
26 certain documents from non-party The Office of Governor Douglas A. Ducey (the "Governor's
Office"). Counsel for the Governor's Office has pre-existing personal obligations on July 28, 2021,
and is unable to participate in oral argument on that date. Counsel's conflict extends to the week

1 immediately preceding July 28, 2021 and the days immediately following that date.

2 Accordingly, the parties and the Governor's Office respectfully request and stipulate that the
3 oral argument be continued for approximately one week, with the argument rescheduled for a date
4 on or after August 4, 2021. This brief continuance will allow the participation and adequate
5 preparation of counsel.
