AFFIDAVIT OF EZRA YOUNG, ESQ.
IN SUPPORT OF MOTION FOR TAXING OF COSTS

I hereby swear or affirm that:

1. Through my law firm, I represented Plaintiff-Appellant, Dr. Rachel Tudor, for a substantial portion of her ultimately successful trial proceedings as well as in her direct appeal and defense against cross-appeal at the U.S. Court of Appeals for the Tenth Circuit.
2. On September 21, 2018, the Clerk of Court for the Western District of Oklahoma taxed costs incurred at the trial court level up through June 20,

2018, in the amount of \$11,117.94. *See* ECF No. 339. These costs are still outstanding.

3. I am now seeking additional taxable costs for taxable costs incurred after June 20, 2018.
4. In addition to the \$11,117.94 taxable costs already awarded, I am seeking \$531.85. The amount of new costs sought is calculated as follows:

5. Additional information.

- a. Printing of documents for courtesy copies of lengthy filings for the Court was necessary to the prosecution of this case.
- b. On June 21, 2018, I directly paid FedEx Office \$227.57 to print courtesy copies of my motions seeking taxable costs and my and co-counsel's joint motions for attorneys' fees.
- c. In light of the Clerk's practice of reimbursing printing costs at a rate no more than \$.15 per page, the table below indicates the number of pages per item at \$.15 per page:
