ORDER TO ENLARGE BRIEFING
SCHEDULE**

1 Pursuant to this Court's Standing Order (ECF No. 38-1) and Local Civil Rules 6-2 and 7-
2 12, the Parties hereby stipulate to and respectfully request entry of a Court order enlarging the
3 time for summary judgment briefing consistent with the following schedule:

- 4 • Defendants' combined opposition to Plaintiffs' motion and cross-motion for
5 summary judgment is due August 16, 2021.
- 6 • Plaintiffs' combined reply in support of their motion and opposition to Defendants'
7 cross-motion is due August 30, 2021.
- 8 • Defendants' reply in support of their motion is due September 13, 2021.

9 This is the fifth time modification request by the Parties. As discussed in the prior request,
10 Defendants made Plaintiffs a settlement offer. The Parties have made progress in their discussions
11 but require additional time in the schedule to negotiate a resolution to this matter. To that end, the
12 Parties stipulate and respectfully request that the Court enter the proposed stipulated schedule.
13 The only effect on this Court's schedule will be to extend the conclusion of summary judgment
14 briefing by 30 days. The Parties respectfully submit that proceeding this way would present the
15 most efficient use of the Court's and the Parties' resources.
