**UNOPPOSED MOTION FOR LIMITED EXTENSION
OF DISCOVERY PERIOD**

Plaintiff Gerald Bostock, pursuant to Fed. R. Civ. P. 15(a)(2) respectfully moves the Court to enter an order extending the discovery deadline in this case by 22 days to December 14, 2021, for the limited purpose of Plaintiff taking the depositions of Stacey Merritt and Leslie Moore. Defendant has advised that it does not oppose this motion. The reasons for this unopposed motion are as follows:

1. The Court previously extended the discovery deadline in this case to the current deadline of November 22, 2021. (Docs. 64, 70, 80, 91, and 97).
2. The parties have attempted to schedule the depositions of Merritt and Moore, but due to their availability have not been able to do so prior to the conclusion of the current discovery deadline.

3. Ms. Merritt and Ms. Moore are both available to be deposed on December 14, 2021. It is expected that each deposition will only last for half a day and therefore can both be conducted on December 14, 2021, consecutively. The parties believe this would be most conducive to a prompt and final conclusion of all depositions.

4. For the reasons stated herein, Plaintiff respectfully requests and Defendant does not oppose that the discovery period in this case be enlarged for twenty-two (22) days through December 14, 2021, for the limited purpose of Plaintiff taking the depositions of Stacey Merritt and Leslie Moore.

5. A proposed Order granting this request for an extension is submitted with this motion.
