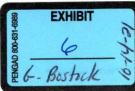

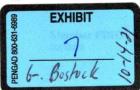

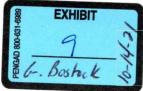

As observed in all reimbursement transactions, this one does not include any documentation or receipts to support the reimbursement. Provide a detailed list of all items and their cost purchased by you for this luncheon for which you claim reimbursement. Also, please explain why the ABC donation was deposited in the GAL account which is an account completely separate in purpose from ABC or Friends of CASA.

10 The audit revealed GAL funds used to sponsor a Hotlanta Softball league (HSL) for the alleged purpose of raising awareness of the CASA program. Part of these expenses incurred included a reception in Birmingham AL. Provide an explanation of why you believe that the administration of the Juvenile Court of Clayton County would consent to GAL funds dedicated to the recruitment of CASA volunteers in Clayton County be spent to sponsor a softball team in a league outside of Clayton County. Did you recruit any volunteers for Clayton County CASA directly as a result of this sponsorship? If so, you must provide the name and contact information of that person. Provide an explanation how the expenditures incurred in Birmingham AL are associated with the recruitment, training, and retention of CASA volunteers in Clayton County GA.

Per your request, I am submitting this memo to provide information regarding questions relating to the Friends of Clayton County CASA Inc, DBA GAL bank statement transactions.

Ikea- Office Supplies (2 halogen bulbs for lamps in CASA office) @ \$6.99 each totaling \$15.10 on 1/27/11 and \$37.79 for office computer stand used for printer and paper in CASA office, Dollar General- yellow folders for Duck Derby Packets \$1.80 on 7/7/10, Dollar General-poster board for CASA car wash fundraiser \$3.21 on 7/08/11, Dollar General 12/2/12-2 stuffed animals @ \$3 each, 1 truck @ \$5, 1 bubble set @\$1, 1 doll @ 5, and 1 art set @\$5 totaling 23.54 for ABC Toy Party donation for relative caregiver children residing in Clayton County. Best Buy- netbook and carrying case \$249.97 on 4/6/10 utilized by CASA program staff and Clayton County CASA volunteers (stored in the CASA office), Best Buy program camera \$119.97 on 1/25/12 to be used for CASA events (stored in CASA office), Lowes 8/30/11- materials including lumber and hardware for Darlin' Duck Derby duck launch tower totaling \$321.40 (supplies gathered by CASA volunteer Angel Ramos with military ID in order to obtain Lowe's discount) and is stored at Clayton County Central Warehouse, Home Depot 9/22/11 screws for Darlin' Duck Derby race course and duck launch tower stored at Clayton County Central Warehouse. Home Depot 9/23/11- wood beams for support of Darlin' Duck Derby duck launch tower @ \$79 and box plastic roll @ \$99 for race course totaling \$188.75 stored at Clayton County Central Warehouse.

Fuel for county vehicle 2010 Gulfstates Regional Victim Witness Conference Shell in Forsyth 7/30/10 and Enmark Savannah 7/30/10. QT 4/8/11 (coffee) for Clayton CASA volunteer Mabel Swaybe en route to visit assigned youth at Augusta Regional Detention Center.

- 3. Clayton County car #39 was taken to Cactus Car Wash 5/18/11 (\$20.95 for basic exterior wash and interior clean-up), as the windshield, exterior, and interior were in deplorable condition. Attempted to get vehicle serviced by county but advised that inmates were no longer providing this service as part of maintenance of the vehicle. Vehicle was being driven to Young Harris for the required Ga CASA Council of Programs meeting.

Planning for volunteer recruitment and CASA awareness campaign among AT&T employees to benefit Clayton CASA and other metro Atlanta CASA programs. Mr. Burton volunteered more than 36 hours throughout February and early March working on this campaign. He was recruited through the HSL sponsorship. Location selected based on convenience of AT& T consultant. Cowtippers 3/13/13- Delivery of CASA brochures and marketing materials for the AT&T recruitment campaign and dinner meeting to review materials with AT&T I.T. Consultant Chris Burton and guest. Blakes/Levy Restaurant at Phillips Arena 3/14/13- guest of Edwin Mesa, CNN journalist for CNN night with the Atlanta Hawks. Mr. Mesa is known for his journalistic abilities to expose human trafficking issues, especially relating to children. Mr. Mesa has provided insight on these abuse issues to help strengthen Clayton CASA's ability to advocate for these child victims. Clayton CASA staff recently attended a local training on Child Trafficking. Light refreshments purchased to show appreciation. Woofs 2/12/13- Appetizers/Beverages for AT&T I.T. Consultant Chris Burton prior to attending the Ga CASA Luncheon and Fashion Show committee meeting. Mr. Burton wanted to get additional information about the statewide CASA network, and specifically the metro Atlanta CASA programs for the marketing and recruitment plan he was putting together for CASA. Mr. Burton included information about the Ga CASA fundraiser to help sell tickets and solicit donations. This location was selected for his convenience, and it's proximity to the Ga CASA Luncheon and Fashion Show committee meeting. El Torero 2/12/13- Follow up dinner meeting with AT&T I.T. Consultant Chris Burton and Jorge Palachios, manager of El Torero. Mr. Palachios volunteered more than 300 hours November through December, supporting the Clayton County CASA ABC toy drive and the Metro Atlanta CASA 5k Superhero Run at Piedmont Park,

specifically by targeting Hispanic communities throughout Atlanta. Mr. Palachios also recently donated to the annual Ga CASA Luncheon and Fashion Show, and has pledged continued support to metro area programs and specifically Clayton County CASA. It is anticipated that he will be a prize vendor for the upcoming Darlin' Duck Derby and will assist with derby ticket sales. Mr. Legnon is a Clinical Director for head trauma patients at CHOA and sees many patients that end up receiving CASA advocacy services due to injuries caused by abuse. He was recruited as a volunteer for the annual Ga CASA Luncheon and Fashion Show event held in March. He has pledged continued support of metro CASA programs, specifically Clayton CASA and the upcoming Darlin' Duck Derby. Mr. Legnon was recruited through the HSL sponsorship. Birch Communications is the phone company that provided services to the Friends of Clayton County CASA Inc board office that housed two county employees- Special Judicial Assistant and CASA Volunteer Recruiter/Trainer, storage, volunteer work space, and volunteer training room. When the board office was closed, final bills were paid through GAL funds, noting that the advisory board account had covered all previous phone bills.
- 9. The referenced reimbursement was for the annual 2012 ABC Christmas Luncheon for relative caregivers and foster families in Clayton County- food and supplies were purchased at Sam's Wholesale Club in Morrow (purchase had to be placed on my personal credit card)- receipt filed and attached to the GAL Batch Form dated 12/7/12, along with a copy of the referenced \$500 donation check # 23078 from Speedway Children's Charities. To accommodate the schedules of ABC volunteer Jane Glaze and Clayton County CASA program sponsor, ABC supporter, and Duck Derby volunteer, Jon Crane, supplies needed to be purchased on December 7th prior to Heritage Bank opening that morning (event was held on December 8<sup>th</sup>). Ms. Glaze had been unable to get to the bank prior to cash or deposit the check from Speedway Children's Charities into the ABC account, which had been designated by the ABC volunteer group to be used to cover the expense for the annual luncheon. I met both Ms. Glaze and Mr. Crane at Sam's Club and used my personal credit card, as Ms. Glaze and Mr. Crane were not prepared to make the purchase on their personal credit cards. The check was deposited in the GAL account with reimbursement check issued to me.
- 10. The sponsorship of a HSL softball team in Atlanta was discussed with Friends of Clayton County CASA Inc board members Guy Alexander and Sabrina Crawford prior to committing the funds. The intent behind this sponsorship was clearly to promote the Clayton County CASA program, recruit potential volunteers, educate the Atlanta area about child abuse and neglect issues, and to secure potential Darlin' Duck Derby sponsors and derby ticket sales. HSL is an active city

member of the Amateur Sports Alliance of North America (ASANA) and the North American Gay Amateur Athletic Alliance (NAGAAA), and happens to be the second largest league in the United States. It attracts primarily male participants throughout the Atlanta area, including Clayton, Cobb, Dekalb, Fulton, and Gwinnett counties. Male volunteer recruitment is a high priority for all CASA programs, and there is no residency requirement for volunteers. Sponsorship allowed the program name to be listed on the team t-shirt, posted on the team banner which is displayed at every game during the ten week season (which will run through July) as well as displayed at tournaments (including Birmingham, which was held in March), and to receive three separate email acknowledgements to league members. The sponsored team is in the D- Division, which is the largest division of HSL with 19 teams. Additionally, HSL selects an annual charity to support with Lost N Found (Finding Safety and Shelter for Atlanta's LGBT Youth) being the chosen organization for 2013. By educating league members on what CASA is and the volunteer services needed, it will place CASA in contention for possible selection by the league next year. Providing light refreshments at an informal reception in Birmingham, allowed opportunity to speak with league members as well as other athletes about CASA and the need for volunteers, specifically male volunteers. Recruitment has been on-going. Chris Burton with AT&T has assisted Clayton County CASA and other metro Atlanta CASA programs with a marketing campaign in the Atlanta area as a result of this sponsorship. Additionally, through this effort, two individuals volunteered for the annual GA CASA Luncheon and Fashion Show held in March (Scott Legnon with Children's Healthcare of Atlanta, and Edwin Mesa, journalist with CNN). Clayton County CASA benefits from this event through state office support of Clayton County CASA volunteers by means of training, specifically pre-service metro training and also other in-service training opportunities including the annual Ga CASA conference. It is also anticipated that Dragon Con Atlanta will become a prize donor or sponsor for the 2013 Clayton County CASA Darlin' Duck Derby, and that league members will be purchasing duck derby tickets as well as assist selling them. Conversations with the Heery Corporation, which also sponsors a softball team, are also underway as a result of this sponsorship.
