2.

I am currently the Director of Internal Audit for Clayton County ("the County") and held this position in 2013.

3.

In May 2013, I oversaw an audit of the Guardian Ad Litem ("GAL") bank account owned by Friends of Clayton County CASA, Inc. ("FCCC") and maintained by Gerald Bostock. The audit was conducted by Leslie Moore, who was an associate internal auditor at time under my supervision.

4.

Although audits written by the County's Internal Audit Department do not as a matter of practice identify specific individuals and focus on identifying problems and recommending to managers changes to procedures and processes, in this instance, I agreed with Ms. Moore's conclusion that Mr. Bostock had spent funds from the GAL account on expenses that were not authorized by the Memorandum of Understanding ("MOU"), and that he had otherwise mishandled the GAL account. The changes recommended in the audit were intended to prevent such wrongdoing from occurring again in the future.

5.

If I had been given the responsibility of deciding what personnel action to take based on what I learned during the audit, I would have terminated Mr. Bostock's employment. Based on my review of the evidence gathered during the audit, Mr. Bostock treated the GAL account like a fundraising and marketing account, which was not authorized under the terms of the MOU.
