**JOINT MOTION FOR TELEPHONIC STATUS CONFERENCE**

Defendants, Southeastern Oklahoma State University, ("SEOSU"), and The Regional University System of Oklahoma ("RUSO"), ("Defendants"), and Plaintiff Rachel Tudor ("Plaintiff") respectfully request this Court schedule a telephonic status conference. In support of the Motion, the Parties submit the following:

1. On September 13, 2021, the U.S. Court of Appeals for the Tenth Circuit issued its ruling in the appeal and cross-appeal of this matter. In that ruling, the Tenth Circuit reversed this Court's decision regarding reinstatement and front pay and remanded. [Doc. 357].
2. On September 24, 2021, Plaintiff's prior counsel, filed a Notice Concerning the Appellate Process and Forthcoming Supplemental Motions. [Doc. 360]. Plaintiff's prior counsel then filed a Second Motion for Costs, Brief in Support of Second Motion for Costs and Second Motion for Attorney Fees on September 27, 2021. [Docs. 361-363].

3. On October 12, 2021, this Court entered its order regarding reinstatement in accordance with the Tenth Circuit's ruling, and directed the Parties to brief the issue of front pay calculation. [Doc. 366].

4. Defendants and Plaintiff's counsel both filed separate objections to Plaintiff's second motions for fees and costs on October 18, 2021. [Docs. 367 and 369]. Prior counsel to Plaintiff filed their reply on October 22, 2021. [Doc. 375], with Plaintiff requesting leave and filing a surreply. [Docs. 376, 378 and 381].

5. Counsel for Plaintiff filed her renewed Motion for Post-Judgment Interest and Tax Offset on October 18, 2021. [Doc. 371], which Defendants responded to on November 8, 2021.

6. Defendants filed a Motion to Stay Plaintiff's Motion for Recalculation of Damages on November 22, 2021. [Doc. 384]. This Court granted Defendants' motion on November 29, 2021. [Doc. 386].

7. The Parties seek a telephonic status conference in order to discuss the pending stay, appeal and settlement opportunities.

WHEREFORE, the Parties respectfully request the Court enter an order setting a telephonic status conference in order to facilitate the Parties' discussions referring to the pending stay, appeal and settlement opportunities.
