


Chairperson Summary**

Name: Diamond, Ashley **GDC#:** 1000290565

Personal Information: Offender Diamond is a 41-year-old transgender female. Denies intersex diagnosis. She is 5'10" tall and weighs 135 lbs. She prefers female pronouns. She made conflicting statements to the classification chairperson as she stated that she has no preference on male or female facility as long as she is housed according to her security level. Then she stated that if there is a preference, she is requesting a female facility. She states she takes hormone treatments.

Classification Information: Victim screening indicates a victim status. She has no sexual or violent criminal convictions or institutional behavior.

Facility Recommendation: The facility Classification Chairperson and Warden recommend that the offender remain housed in a male facility.

SCC Interview: Offender Diamond confirmed that she is a transgender female with no intersex diagnosis. She prefers female pronouns. She is sexually attracted to males. She advised the SCC committee that she prefers a female facility because she "has no functioning genitalia," and she can "express herself as a female better at a female facility." Further in the conversation, she was discussing that she felt comfortable at a lower profiled facility, such as Rutledge or Central. She stated that the Warden, the Regional Director and Mr. Toole came by and discussed housing options with her and that Rutledge would be a good option. She stated that she was most concerned with being housed by her level of security and not being housed with violent offenders. She stated it wasn't the facility type (male or female) that concerned her as much as the security level aspect.

Offender Diamond was waiting on medical during the SCC interview. She stated that she was feeling sick due to hormone withdrawals. She further stated that medical could not locate any records for her and that she did not have a file. She stated that she is to report directly to medical at the conclusion of this interview.

We also discussed her Mental Health status. She is scheduled for her initial MH interview next week, which will determine her MH status. She was a level 3 when she was released from prior custody. She also described feelings of discomfort associated with her gender, which is an indication that she may suffer from gender dysphoria. She states that she was previously diagnosed with gender dysphoria.

SCC Chairperson: Diamond expressed no current safety concerns. She did express safety concerns about being housed at a high level security facility, following her completion of diagnostics. She stated that being housed with male offenders is not as much of a concern for her than the security type of offenders at certain facilities.

Diamond is under the impression that she only has a few months left on her sentence. However, her documents indicate that her max release is 2/2024 and OA Director, Kenneth Mantle states that she has pending charges in Floyd County.

SCC Housing Recommendation: Because the PREA standards forbid decision-making based on genital status, I cannot factor her statement that she "has no functioning genitalia" in my housing recommendation. Furthermore, Diamond is under the impression that she is to be released in February 2020, but after review of documentation and consultation with OA Director, Kenneth Mantle, her max release date is 2/2024 and she has pending charges in Floyd county that she has not been sentenced for. Based on this information, she is a potential escape risk once she is informed of her updated release status, therefore she may require a more secure facility.

At this time, my housing recommendation remains neutral as I feel she would function well in either facility type. She has expressed that she is having mental health issues related to her gender and that she would be more comfortable with her gender expression in a female facility. However, she also expressed that she previously felt comfortable in other "low-security" male facilities.
