**JOINT STATUS REPORT**

1 In advance of the next status conference, the parties hereby provide a status update  
2 on the litigation.

3 First, the Court granted Plaintiffs' Unopposed Motion to Withdraw Motion for Class  
4 Certification. *See* ECF No. 112.

5 Second, in response to that Motion, Defendant has filed its Unopposed Motion to  
6 Withdraw Defendant's Motion to Compel Production. *See* ECF Nos. 94 & 113.

7 Third, Plaintiffs' counsel has disclosed to Defendant that D.H. will independently  
8 seek male chest reconstruction surgery outside of AHCCCS as soon as possible, and he has  
9 filed a motion to voluntarily dismiss his claims.

10 Fourth, Plaintiff John Doe has begun to produce his medical records on a rolling  
11 basis as ordered by the Court. *See* ECF No. 102. Plaintiff John Doe anticipates that  
12 production of his medical records will be complete on or around October 13, 2021.

13 Fifth, the parties continue to work cooperatively to conduct discovery in an efficient  
14 and productive manner, including scheduling of depositions.

15 Finally, the Plaintiffs believe that because this matter has been significantly  
16 streamlined due to the withdrawal of the class certification motion and motion for voluntary  
17 dismissal of Plaintiff D.H.'s claims, a trial date can be set for this matter in the summer of  
18 2022. Defendant believes discovery will not be concluded before March 25, 2022 and  
19 would propose a schedule that would have this case ready for trial at the end of 2022. The  
20 parties agree a bench trial is appropriate and request that the Court set aside 3-4 days for  
21 trial.
